The County Attorney's office request approval to reclassify a 1.00 Legal Assistant Senior to a Paralegal as determined by Central Human Resources Classification Compensation unit.

This is a management initiated reclass of the position due to the need to sustain added responsibility for trial and litigation support as the result of hiring new attorneys and shifting staff responsibilities. Added duties include increased responsibility for litigation support and project coordination and management. The primary purpose of this position is litigation support to assigned attorneys, project management and technical expertise and training.

For the current year there is no budget impact. The current top step of the new classification (\$69,961) is \$3,464 higher than the current classification's top scale. It is anticipated that in subsequent fiscal years the financial impact of the new classification will be funded within the

department's budget.
