### General Information

**1. What action are you requesting from the Board?**

December 2, 2012, the Board approved a transfer of \$10,000 from general fund contingency to assist the Veterans Affairs Administration and community partners in an effort to house 87 chronically disabled veterans. This short presentation will update the Board on the status of the funds and the ongoing effort to house veterans.

**2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.**

The HUD Veterans Affairs Supportive Housing (HUD-VASH) is a critical program in ending homelessness for Veterans. The program is funded by Housing and Urban Development (HUD) and the Veterans Affairs Administration (VA) and combines rental assistance and clinical services to ensure chronically homeless veterans get off the streets, into housing and have the support services they need to stay housed. HUD-VASH vouchers are allocated to communities based on need. Multnomah County currently has 305 vouchers,

which means we have the ability to serve 305 disabled homeless veterans through this program.

The County's funds were combined with \$10,000 each from Home Forward, City of Portland and United Way of the Columbia Willamette for a total of \$40,000 and provided the flexible assistance needed to utilize the vouchers. A report will be presented to the Board. On average, \$300 was spent per veteran housed.
