MULTNOMAH COUNTY, OREGON

ORDINANCE NO. 360

An Ordinance relating to the park activities and to the Multnomah County Parks Commission; amending Ordinance No. 277 and Multnomah County Code Section 10.10.280 and 10.10.340; and enacting new provisions.

Multnomah County ordains as follows:

SECTION 1. Ordinance No. 277, Section 5.4, is amended to read:

"Sec. 5.4. Be authorized to raise funds for park purposes as best serves the goal of the Commission and the parks master plan. All funds raised and revenues generated by the Commission shall be dedicated to the development, operation and maintenance of parks. To this end, all funds raised and collected pursuant to this ordinance shall be credited to the Multnomah County Parks Commission Fund which is hereby established. The fund shall be used exclusively for administration of this ordinance."

SECTION 2. Ordinance No. 277, Section 10, is amended to read:

"Section 10. Quorum and voting.

- A. [Eight members of the Commission] A majority of the members of the Commission shall constitute a quorum for the conduct of business."

SECTION 3. Section 4 of this ordinance is added to and made a part of MCC 10.10.010.

SECTION 4. "Commission" means the Multnomah County Parks Commission.

SECTION 5. Section 10.10.280 is amended to read:

"Except as expressly provided in this chapter, no person shall expose, advertise or offer for sale any article or thing, or station or place any stand, cart or vehicle for the transportation, sale or display of any article or thing, unless the person is a regularly licensed concessionnaire acting by and under the written authority of the Director.

SECTION 6. Sections 7 to 9 are added to and made a part of MCC 10.10.340.

SECTION 7. The requirements of this section that a permit be obtained before a person may act as a concessionaire shall not apply to fund-raising activities of the Commission for parks purposes, within those parks defined in this section as "neighborhood parks". Provided, however, the Parks Commission shall coordinate its fund raising activities with the Park Director.


SECTION 8. "Neighborhood parks" are those parks marked "neighborhood park" on the attached map, which is incorporated herein by this reference.

SECTION 9. The addition or deletion of neighborhood parks on the map referred to above shall be done by the Board by ordinance.

ADOPTED this 6th day of January, 1983, being the date of its second reading before the Board of County Commissioners of Multnomah County, Oregon.


