## General Information

### 1. What action are you requesting from the Board?

Authorize the Chair to execute an intergovernmental cooperative agreement (IGA) for the Regional Coalition for Clean Rivers and Streams in substantially the form attached, provided that any modifications may not result in a material increase in the County's obligations or a material decrease in the County's benefits, and the Chair is authorized to execute any ancillary documents necessary to effectuate the purpose and intent of these agreements.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

This IGA is a continuation of the collaborative stormwater and water quality outreach and education efforts by several Portland area local jurisdictions that have regulatory requirements in their National Pollutant Detection and Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) Permits. For over 15 years, this coalition has been actively collaborating in shared messaging and media buys. This new IGA reflects changes in the membership of the group and includes other technical changes.

### 3. Explain the fiscal impact (current year and ongoing).

This IGA commits the County to \$2,000 in funding towards the collaborative outreach effort. The County has already budgeted that amount for these purposes.

### 4. Explain any legal and/or policy issues involved.

The work by this coalition fulfills NPDES MS4 permit requirements, which are part of the

federal mandate under the Clean Water Act.

**5. Explain any citizen and/or other government participation that has or will take place.**

This is a coalition of local jurisdictions that meets approximately monthly to develop and implement outreach strategies to influence clean water behaviors.
