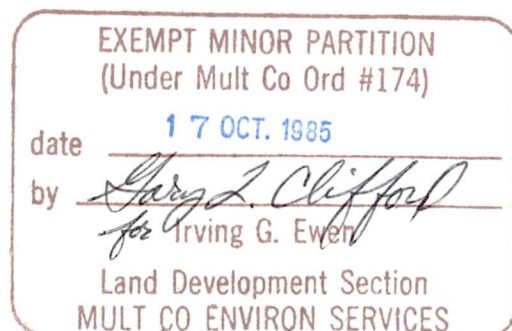

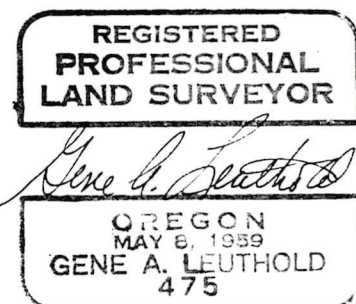

Beginning at a brass cap monument marking the Southwest corner of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 36; thence South $87^{\circ} 52' 27''$ East, a distance of 67.83 feet to an iron pipe at the Southwest corner of that certain tract of land conveyed to Harry Burkholder and Mary A. Burkholder, by deed recorded February 4, 1948 in Book 1241 page 209, Deed Records; thence North $0^{\circ} 08' 37''$ East, along the West line of said Burkholder tract, a distance of 164.80 feet to the Northwest corner thereof; thence South $87^{\circ} 52' 27''$ East, along the North line of said Burkholder tract, a distance of 108.79 feet, more or less, to a point South $87^{\circ} 52' 27''$ East, 180.0 feet distant from the West line of said Section line; thence North $4^{\circ} 30' 08''$ West 290.00 feet to the true point of beginning of the herein described parcel; thence continuing North $4^{\circ} 30' 08''$ West 214.67 feet to a point in the Southerly line of the Crown Point Hwy.; thence on the arc of a 603.14 foot radius curve to the left (the chord of which bears North $82^{\circ} 11' 20''$ East 81.47 feet) a distance of 81.52 feet to a point of tangency; thence continuing along said right of way North $78^{\circ} 19'$ East 22.78 feet; thence South $11^{\circ} 43' 52''$ East 207.08 feet; thence South $78^{\circ} 08' 20''$ West 131.07 feet to the true point of beginning.

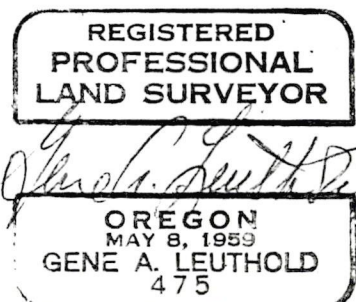
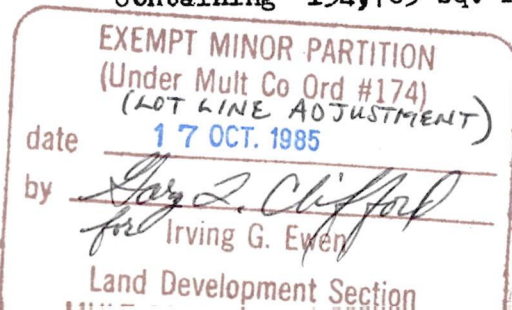

Knieriem and Robert Knieriem, by deed recorded January 26, 1948 in Book 1238 page 497, Deed Records; thence South $78^{\circ} 29' 25''$ West along the South line of said Knieriem Tract 206.84 feet to the southwest corner thereof; thence North $11^{\circ} 43' 52''$ West along the West line of said Knieriem tract 204.13 feet to the Northwest corner thereof, and a point in the Southerly right of way line of Crown Point Highway; thence South $78^{\circ} 19' 10''$ West along the Southerly line of said right of way 50.00 feet; thence South $11^{\circ} 43' 52''$ East 207.08 feet; thence South $78^{\circ} 08' 20''$ West 131.07 feet; thence South $4^{\circ} 30' 08''$ East 290.00 feet to the true point of beginning...

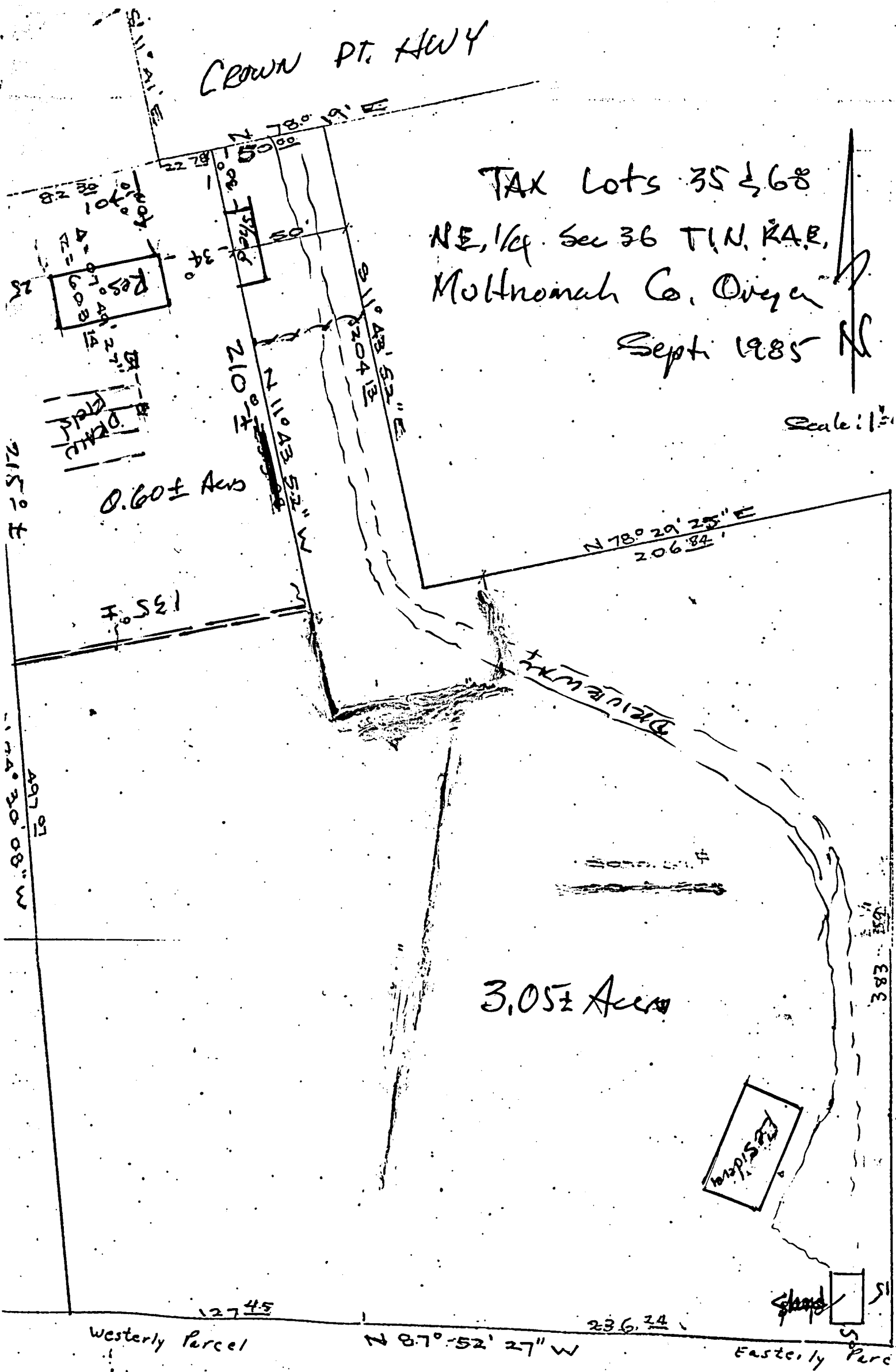

Computed ties to found points to relate them to deed calls. Held found points along the East property lines and related to same.
