DAVID SMALLWOOD, TIM RAMIS, MARK DRAKE, RON HEINTZMAN AND JOHN PRAGGASTIS PRESENTED TESTIMONY EXPRESSING CONCERN WITH THE PROPOSED RESOLUTION AND RESPONSE TO BOARD QUESTIONS.

AMENDMENT #1

UPON MOTION OF COMMISSIONER COLLIER, SECONDED BY COMMISSIONER HANSEN, IT WAS UNANIMOUSLY APPROVED TO AMEND PAGE 1, NEXT TO LAST PARAGRAPH TO READ AND MOVE TO PAGE 2 MIDDLE OF PAGE AS FOLLOWS:

AMENDMENT #2

UPON MOTION OF COMMISSIONER COLLIER, SECONDED BY COMMISSIONER HANSEN, IT WAS UNANIMOUSLY APPROVED TO AMEND PAGE 2, MIDDLE OF PAGE TO READ:

"IF THE PROPOSER RELIES ON THE PRIOR EXPERIENCE OR UNIT HOUR PRODUCTION OF A PARTICIPATING ENTITY OR SUPPLEMENTAL SERVICE PROVIDER FOR THE PURPOSE OF MEETING THE REQUIREMENTS OF THIS RFP, THEN:"

AMENDMENT #3

COMMISSIONER COLLIER MOVED AND COMMISSIONER HANSEN SECONDED TO AMEND ATTACHMENT A, SUBSTITUTE 1, STARTING WITH SMALL PARAGRAPH A ON PAGE 2 THROUGH THE END OF PAGE 3 TO READ:

"a. Each participating entity must individually be prepared to guarantee that all of the franchise requirements will be met and be jointly and severally liable for any breach of contract, tort, rule violation, infraction, or penalty imposed.

b. Written documentation shall be submitted that describes the precise nature of the legal relationship of the participating entity(ies) and the supplemental service providers including an opinion letter from legal counsel, admitted to the Oregon State Bar, confirming the legal validity and enforceability of the agreement.

c. A participating entity or a supplemental service provider providing any unit-hours of production to the franchise shall document its experience at the commensurate level. For example, if unit-hours are proposed at 10 percent, there must be demonstration of experience at that level.
