1. What action are you requesting from the Board?

Approval of budget modification Nond-15, adding \$8,000 from the City of Portland to United Way of the Columbia-Willamette to pass through for mini-grants from the Complete Count Committee.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Commissioner Deborah Kafoury Co-Chairs the 2010 Complete Count Committee to increase participation in the Census. The Committee raised funds from foundations, businesses, and other governmental partners to provide mini-grants to non-profit organizations to do outreach in their communities for the Census. The City of Portland committed \$8,000 to this effort. After the contract was approved by the County, United Way of the Columbia-Willamette agreed to be the administrative sponsor for this project. This budget modification acknowledges the receipt of these funds by District 1 and the distribution to United Way.

3. Explain the fiscal impact (current year and ongoing).

This is a one-time pass-through revenue and expense specifically related to Census 2010 activities.

Mini-grant funds were distributed by a committee including community members and city and county employees. The Complete Count Committee includes over 60 community partners.
