**R-3 Briefing on Willamette River Bridge Funding. Presented by Karen Schilling and Cecilia Johnson.**

CECILIA JOHNSON AND KAREN SCHILLING PRESENTATION REGARDING EFFORTS TO GARNER SUPPORT FOR A BALLOT MEASURE REQUESTING A TWENTY YEAR \$24.00 PER CAR PER YEAR VEHICLE TAX FOR UPKEEP OF THE SELLWOOD AND OTHER WILLAMETTE RIVER BRIDGES. MS. SCHILLING ADVISED STATE AND FEDERAL FUNDING DISCUSSIONS ARE ONGOING. IN RESPONSE TO A QUESTION OF CHAIR WHEELER, MS. SCHILLING REPORTED THAT OF THE 12 JURISDICTIONS WHO HAVE TO AGREE THAT THE MATTER BE PLACED ON THE BALLOT FOR VOTER CONSIDERATION, THE CITY OF TROUTDALE VOTED IN OPPOSITION; THE CITY OF MAYWOOD PARK MAY NOT SUPPORT THE MATTER; AND THAT THE CITY OF PORTLAND VOTED IN SUPPORT ON JANUARY 9, 2008. MS. SCHILLING ADVISED FOUR EVENING PUBLIC HEARINGS HAVE BEEN SCHEDULED IN JANUARY AND FEBRUARY.
