In My Opinion: The following is true...
**Health, Safety and Americans with Disabilities Issues at
the proposed Bybee Street Light Rail Station**

❖ Diesel Exhaust Fumes and Coal Dust:

This will be the most polluted rail station in the Tri Met system. Three huge diesel locomotives pound through this station day and night 35ft. from the station. The coal trains will bring another 30 locomotives per day causing more exhaust fumes and dust. *Diesel exhaust fumes are carcinogenic and proven to be horribly damaging to fetuses and infants.*

❖ ADA Compliance

The Bybee Street Overpass is **NOT** ADA compliant. Title 642.2 of the 1990 Americans with Disabilities Act mandates a 5ft grade. The grade here is 8ft with no platforms. Tri Met will lose its federal funding for non-compliance.

❖ Personal Safety

The platform is under a bridge next to a railroad track. A rider could get mugged or worse and not heard or seen by a passing motorist.
