## Σ The Sigma Project

The Sigma Project is a Portland nonprofit corporation founded to grow sustainable local produce for the disadvantaged community while creating independence through teaching the process. We are decreasing the number of food insecure individuals and families in our community by addressing key constraints to food accessibility by developing critical strategies and implementing solutions with innovative tools and practices creating sustainable food systems.

Our project ensures Portland families have access to fresh local nutritional food. We transform lawns and empty lots into suppliers of fresh local produce for the community. Uniting land lenders, volunteers, and experts together with all the necessary materials and supplies for this goal. We maintain pick up and home delivery, providing on site training and off site seminars teaching the process, creating independence, stronger community, and elevating the human condition. We provide the most disadvantaged members of the community with their only source of free sustainable fresh local organic fruits and vegetables essential to their health and well being they would otherwise do without.

The Oregon Department of Human Services estimates there are currently over 100,000 households in the city of Portland having trouble putting food on the table and receiving food benefits. Over 36% are children. Oregon has the highest rate of childhood hunger in the country.

The Food and Agriculture Organization of the United Nations estimates that a 100 percent increase in food production will be required to feed the population by 2030 and avert further food insecurity. The sustainable production of sufficient plant products is required if we are to maintain the ability to produce enough food for the population of the United States now and into the future.

The latest government report released September 2012 (Coleman Jensen) states 17.9 million households in 2011, approximately 1 in 7, were food insecure. The highest number ever recorded.

Food accessibility must go beyond the provisioning of emergency supplies. It necessitates having access to sustainable sources that are produced in ways that sustain ecosystems and builds economic and social equity.

Our community will have a more equitable distribution of essential foods. A nutritional local food system without harmful chemicals and pesticides; stewardship of the environment and control over our food production.; less dependency on outside sources; less disparity and more independence for the most vulnerable members of the community. A community educated on the purpose and practices of sustainability.

First and foremost the disadvantaged community will have access to essential foods critical for their very survival. Our entire community will benefit from a cleaner healthier environment, easing the staggering costs of the food benefits program, and building economic and social independence and equity. Healthy foods and environment serves everyone in the community.
