Becky, Mary and Matt: I figured out what happened.

Mary sent this revised APR document Jan. 29, as you can see below.

It DOES include the revisions for: #8 and #23 to Exhibit A. It went into the packet of 1-31 that was postponed by the Board.

However, on Feb. 7th, Mary sent ANOTHER revised APR, with Exhibit A, and that version is the one that was uploaded to this week's Board packet. It does not reflect the same changes found in the documents sent Jan. 29th. I don't know what other changes were made to the APR or Exhibit, only that #8 and #23 were removed from Exhibit A in the 1/29 version.

The Feb. 7th version, is of course, the final one that was loaded and that the Board approved.

As Matt said in his e-mail yesterday, the one the Board approved is the one we have to process, and that one is the Feb. 7th version, which has the errors in Exhibit A to the APR.

Matt also mentioned he did not see or review your APR or Exhibit A/documents attached to your APR.

In the future, please make sure the county attorney's office always sees all documents related to an Order, Ordinance, Resolution, etc.

They can't sign off on what they don't see.

As to how you process these documents from your end, Becky, with the incorrect Exhibit approved, I leave to you with input and instruction from Matt, I am just not sure what you need to do.

Matt: my question is whether or not, in the future, what they sent as Exhibit A behind the APR should become an Exhibit behind the Order.

Thanks, everyone, for your input.

Marina will be over shortly to drop off everything to Mr. Ryan for his review.
