time.

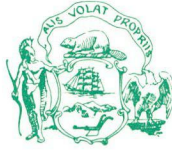
CRAG and MSD are new assignments; these may also involve

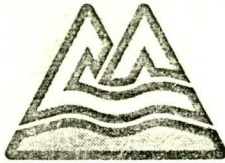
