Mental Disorders in America

Mental disorders are common in the United States and internationally. An estimated 26.2 percent of Americans ages 18 and older — about one in four adults — suffer from a diagnosable mental disorder in a given year.¹ When applied to the 2004 U.S. Census residential population estimate for ages 18 and older, this figure translates to 57.7 million people.² Even though mental disorders are widespread in the population, the main burden of illness is concentrated in a much smaller proportion — about 17 percent, or 1 in 7 — who suffer from a serious mental illness.¹ In addition, mental disorders are a leading cause of disability in the U.S. and Canada.³ Many people suffer from more than one disorder at a given time. Nearly half (45 percent) of those with any mental disorder meet

or more disorders, with severity strongly related to comorbidity.¹

In the U.S., mental disorders are diagnosed based on the *Diagnostic and Statistical Manual of Mental Disorders, fourth edition (DSM-IV)*.⁴

Mood Disorders

Mood disorders include major depressive disorder (<http://www.nimh.nih.gov/health/topics/depression/index.shtml>), dysthymic disorder (<http://www.nimh.nih.gov/health/topics/depression/index.shtml>), and bipolar disorder (<http://www.nimh.nih.gov/health/topics/bipolar-disorder/index.shtml>).

- Approximately 20.9 million American adults, or about 9.5 percent of the U.S. population age 18 and older in a given year, have a mood disorder.^{1,2}
- The median age of onset for mood disorders is 30 years.⁵
- Depressive disorders often co-occur with anxiety disorders and substance abuse.⁵

Major Depressive Disorder (<http://www.nimh.nih.gov/health/topics/depression/index.shtml>)

- Major Depressive Disorder is the leading cause of disability in the U.S. for ages 15-44.³
- Major depressive disorder affects approximately 14.8 million American adults, or about 6.7 percent of the U.S. population age 18 and older in a given year.^{1,2}
- While major depressive disorder can develop at any age, the median age at onset is 32.⁵
- Major depressive disorder is more prevalent in women than in men.⁶

Dysthymic Disorder (<http://www.nimh.nih.gov/health/topics/depression/index.shtml>)

- Symptoms of dysthymic disorder (chronic, mild depression) must persist for at least two years in adults (one year in children) to meet criteria for the diagnosis. Dysthymic disorder affects approximately 1.5 percent of the U.S. population age 18 and older in a given year.¹ This figure translates to about 3.3 million American adults.⁴
- The median age of onset of dysthymic disorder is 31.¹

Bipolar Disorder (<http://www.nimh.nih.gov/health/topics/bipolar-disorder/index.shtml>)

- Bipolar disorder affects approximately 5.7 million American adults, or about 2.6 percent of the U.S. population age 18 and older in a given year.^{1,2}
- The median age of onset for bipolar disorders is 25 years.⁵

Suicide (<http://www.nimh.nih.gov/health/publications/suicide-in-the-us-statistics-and-prevention/index.shtml>)

- In 2006, 33,300 (approximately 11 per 100,000) people died by suicide in the U.S.⁷
- More than 90 percent of people who kill themselves have a diagnosable mental disorder, most commonly a depressive disorder or a substance abuse disorder.⁸
- The highest suicide rates in the U.S. are found in white men over age 85.⁹
- Four times as many men as women die by suicide,⁹ however, women attempt suicide two to three times as often as men.¹⁰

Schizophrenia (<http://www.nimh.nih.gov/health/topics/schizophrenia/index.shtml>)

- Approximately 2.4 million American adults, or about 1.1 percent of the population age 18 and older in a given year,^{11,2} have schizophrenia.
- Schizophrenia affects men and women with equal frequency.¹²
Schizophrenia often first appears in men in their late teens or early twenties. In contrast, women

Good morning and seasonal greetings to you all,


May I presume that my objection to the appointment of Dan Staton to fill the vacancy left by Sheriff Bob Skipper, on grounds that a self admitted felon would not be a good public relations move for the Board, means that some of you remember me?

The result of my effort to stop Dan Staton's appointment, was that he banned me from doing business with Multnomah County for one year. During that time our former Chairman, Jeff Cogen was appointed to fill the vacancy left by Ted Wheeler. As the last week of Sheriff Staton's year long ban began, Jeff Cogen wrote to me and said I was banned again, as a result of my effort to clear up the issue of my citizenship status with the Elections Division.

Dan Staton didn't get each of the essentials for banning one of the people from public premises covered, but neither did Jeff Cogen. Dan at least said the ban was for a time certain, and gave a method for appeal, although when I applied for it, actually getting it proved to be another thing. Mr. Cogen didn't get the time frame addressed, nor an appeal process and his excuse for banning me was really less than legitimate as well, considering violation of Staton's ban was the ostensible cause for his reissuance. Today I am not interested in Dan Staton or his ban, but rather Mr. Cogen's subsequent ban which continues to preclude business.

We all know that Mr. Cogen has had some difficult times in the past few years, although he is reluctant to apologize to me. I have come before this Board to ask if Mr. Cogen's indefinite and apparently "forever ban" against me doing business with the County, will be the source of conflict between this Board and myself. I will not expect your answer today, as I expect you should examine the record of events for yourselves once again, but I will come back next week to ask for your vote on continuing Mr. Cogen's unconstitutionally "indefinite" ban.
