FOR MULTNOMAH COUNTY, OREGON

ORDINANCE NO. 321

An ordinance relating to park activities and amending Multnomah County Code Section 10.10.190(B); repealing Section 6 of Ordinance 312, and enacting provisions in lieu thereof, and creating new provisions; and declaring an emergency.

Multnomah County ordains as follows:

SEC. 1. MCC 10.10.190(B), as amended by Ordinance 312, is amended to read:

The [board] Director may, by [its order] issuance of a permit, allow the consumption of alcoholic beverages on the premises of designated facilities when duly licensed by the Oregon Liquor Control Commission.

SEC. 2. Section 6 of Ordinance 312 is repealed and Section 3 of this Ordinance is enacted in lieu thereof and made a part of MCC Chapter 10.15.

Sec. 3. Park Fees.

The following fees shall be charged and collected by Multnomah County for and prior to the following park uses and activities:

- a) A-frames, picnic areas, etc. at Blue Lake Park shall be as follows: see attached fee schedule.
- b) Alcohol permits at Oxbow and Blue Lake Parks: \$150.00 with \$35.00 refundable.
- c) Overnight camping fees at Oxbow Park: \$5.00 per site per night. Permit must be displayed.
- d) Entry fees at Blue Lake and Oxbow Parks: \$1.00 per car or bus.
- e) [Launch] Entry fees at 43rd Street Boat Ramp: \$1.00 per [launch] vehicle.
- f) Service fees for special events shall be set by the Superintendent.

g) Group user fees at Oxbow Park shall be based on group size as follows:

Up to 15	\$10
16 to 50	\$25
51 to 100	\$50

Youth camps:

Up to 15	\$10
16 to 35	\$15
36 to 75	\$25
Over 75	\$30

h) Swimming fees.

Under six (6) years of age: no charge, must be accompanied by an adult swimmer.

Six years of age or over: \$1.50 from 12:30 p.m. to 3:30 p.m.

Six years of age and over: \$2.00 from 4:00 p.m. to 7:30 p.m.

Sec. 4. Sections 5 and 6 of this Ordinance are added to and made a part of MCC Chapter 10.15.

Sec. 5. Park Use Without Required Fee Is Prohibited.

No person shall engage in a park activity for which there is a fee, without first paying the required fee. Any person engaged in a park activity for which there is a fee shall be required to produce and exhibit the receipt from the director showing fee payment, which the person claims to have, upon request of any authorized person who shall desire to inspect the receipt for the purpose of enforcing compliance with this ordinance or rule promulgated pursuant thereto.

Sec. 6. Penalties.

Any person convicted of a violation of this chapter shall be punished by a fine of not more than \$500.00.

Sec. 7. Adoption.






