ORDINANCE NO. 105

An Ordinance relating to fees for county services.

Multnomah County ordains as follows:

Section 1. Policy and Purpose.

Because of the increasing costs to Multnomah County of providing services to the public and of discharging the legal responsibilities of the county, and because of the decreased availability of general county revenue to defray such costs, the Board of County Commissioners of Multnomah County, Oregon, declares it to be in the interests of the people of the county for the fees established in this ordinance to be imposed and collected by Multnomah County from the persons directly served or affected by the provision of such services and the performance of such responsibilities.

Section 2. Fee for Collection of Support Payments.

Pursuant to ORS 205.320(15), a fee for collection of alimony and support payments equal to three percent (3%) of the monthly obligation of the person making the payment shall be collected from said person; provided that the fee shall not be less than \$1.00 per month and shall not exceed \$4.00 per month.

Section 3. Fee for Legal Forms Provided by Courts Process Division.

For all blank legal forms provided to the public by the Division of Courts Process, a fee of fifteen cents (15¢) per form shall be collected.

Section 4. Fee for Various Services of the Division of Courts Process.

Pursuant to ORS 205.320(14) a fee of \$2.00 shall be charged by the Courts Process Division for each issuance of a writ of execution, with or without garnishment; for each file search conducted by the Division; for each computer print-out supplied by the Division; and for each weekly marriage license list supplied by the Division.

Section 5. Motor Vehicle Accident Report Fee.

For each motor vehicle accident report provided by the Division of Public Safety, a fee of \$10.00 shall be collected.

Section 6. Fee to Service Districts for County Accounting Services.

The Director of the Office of County Management is authorized and instructed to establish and collect fees chargeable to service districts for which the county provides accounting and related financial management services and for which the county provides automated data processing time and services, which shall be equal to the actual cost incurred by the county for providing such services as determined by the Director.

Section 7. Fee for Services of Data Processing Authority.

For the services of the Data Processing Authority in connection with gathering, preparing and providing requested information, a fee shall be charged which shall be equal to the actual cost of providing such services, as determined by the Director of the Office of County Management after consulting with the Director of the Data Processing Authority, plus an

additional amount equal to fifteen percent (15%) of such actual cost to defray the expenses of developing and expanding information base and access systems; provided that the fee charged by the Data Processing Authority to any governmental agency or unit shall be equal to the actual cost of gathering, preparing and providing such information only.

Section 8. Purchasing Handling Fee.

To defray the **expenses** of Multnomah County in providing purchasing and stores services for other governmental agencies and units which do not provide reciprocal services to Multnomah County, a fee shall be charged equal to ten percent (10%) of the value of the goods purchased and handled by Multnomah County on behalf of such agencies and units; provided that no fee charged under this section shall exceed the amount allowable under any applicable contract between Multnomah County and the affected agency or unit.

Section 9. Fees for Certain Services of Division of Assessment and Taxation.

For any print-out or copy of an appraisal card for any tax account, the Division of Assessment and Taxation shall charge a fee of \$1.00; provided that, in any case where print-outs or appraisal cards are requested and provided for more than one tax year or for any tax year other than the then current year, the Division shall charge an additional fee of \$1.00 for each tax account for each such year.

Section 10. Map Reproduction and Loan Fee.

For the services of the Department of Administrative Services in reproducing and loaning maps, fees shall be

charged in accordance with the following schedule:

Section 11. Fees for Copies of Book of Records.

For diazo copies of the Book of Records, a fee shall be charged equal to the actual cost incurred by the Department of Administrative Services for preparing and providing such copies, as determined by the Director of the department; provided that the minimum fee for such copies shall be \$12.00 per roll.

Section 12. Fees for Services of Department of Human Services.

Except where otherwise provided by law, fee schedules for services provided by the Department of Human Services and for recovery of the expenses of the department in performing its responsibilities shall be established by the Director of the department. The fees of the department for services provided to the public shall be based generally

on the cost of providing such services, and shall be established with the objective of effecting maximum possible availability and delivery of services to those in need of them, as provided for in the budget of Multnomah County. The fee schedules shall, where appropriate, be based upon ability to pay. The Director of the department shall revise such schedules at least annually and shall provide copies of the revised schedules to the Chairman of the Board of County Commissioners and the Director of the Budget and Management Analysis Section by March 1 of each year.

Section 13. Revisions of Fees.

Except where otherwise provided by law or by the express provisions of this ordinance, the fees established by this ordinance may be changed or modified by order of the Board of County Commissioners of Multnomah County. In those cases where executive or administrative officials of the county are authorized by this ordinance to establish fees, such officials may revise such fees, from time to time, unless this ordinance or other provisions of law expressly otherwise provide.

Section 14. Adoption.


This ordinance, being necessary for the health, safety and welfare of the people of Multnomah County, shall take effect on the thirtieth day after its adoption, pursuant to Section 5.50 of the Charter of Multnomah County.
