**RESOLUTION NO. 05-037**

Authorizing the Private Sale of a Tax Foreclosed Property to METRO

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County acquired the real property described below through the foreclosure of liens for delinquent property taxes.
- b. The property has an assessed value of \$1,900 on the County's current tax roll.
- c. Although no written confirmation from the Multnomah County Land Use Planning was obtained, we did receive verbal and email confirmation from their office that the property, approximately 10,313 square feet, is unsuitable for the construction or placement of a dwelling thereon under current zoning ordinances and building codes, as provided under ORS 275.225.
- d. METRO has agreed to pay \$100, an amount the Board finds to be a reasonable price for the property in conformity with ORS 275.225.

**The Multnomah County Board of Commissioners Resolves:**


1. Upon Tax Title's receipt of the payment of \$100, the Chair on behalf of Multnomah County, is authorized to execute a deed conveying to METRO, the following described real property:

LOT 3, BLOCK 4, in the duly recorded plat of BURLINGTON, in the City of Portland, Multnomah County, Oregon.



MULTNOMAH COUNTY, a political subdivision of the State of Oregon, Grantor, conveys to METRO, a municipal corporation and political subdivision of the State of Oregon, that certain real property located in the City of Portland, Multnomah County, Oregon more particularly described as follows:

LOT 3, BLOCK 24, located in the duly recorded plat of BURLINGTON

The true and actual consideration paid for this transfer; stated in the terms of dollars is \$100.


