# Justice Reinvestment Works



## PROVEN EFFECTIVENESS

Thanks to the state's Justice Reinvestment financial commitment, Multnomah County's public safety partners were able to create an innovative program designed to reduce use of state prisons for offenders who can safely be supervised in the community. Strategic investments hold those offenders accountable by providing the structure necessary for success in the community. The program addresses the root causes of crime and increases services to victims. The immediate and long term goals of the program aim to save the state money and to make the community safer.

## POSITIVE RETURN ON INVESTMENT

For an \$8.1 million investment in the 2015-17 biennium, **Multnomah County's Justice Reinvestment Program (MCJRP)** has reduced prison operating costs by **\$14 million**. Increased use of Short Term Transitional Leave (STTL) for eligible Multnomah County offenders has allowed the Department of Corrections (DOC) to avoid spending another **\$3.2 million** in operation costs.<sup>1</sup> Subtracting the MCJRP investment of \$8.1 million from the total of \$17.2 million in DOC costs avoided, the MCJRP program has resulted in the state spending \$9.1 million less this biennium and has bolstered the statewide effort to avoid the immediate cost of constructing an expensive new prison.

## HOW IT WORKS



**SAFETY – MCJRP** transforms the criminal justice system by using a highly collaborative, data-driven process designed to reduce the risk of recidivism by evaluating each offender and creating a supervision plan to meet that offender's specific needs.



**ACCOUNTABILITY** – Informed sentencing includes the victim's input and concerns. Dedicated parole and probation and law enforcement officers provide increased oversight and engagement ensuring compliance with customized case plans.



**VICTIM SERVICES** – \$800,000 of MCJRP funds are dedicated to support victims of crime, with particular attention to underserved populations. Through a listening session and a competitive process, community identified proposals were funded, including services to non-English speakers.



**TREATMENT – MCJRP** begins the work of changing offender behavior with a robust assessment and evaluation. Offenders staying in the community may receive mental health, addiction and cognitive treatment, housing, employment, mentoring, parenting, education and transportation services. MCJRP funds a jail Treatment Readiness Dorm designed to stabilize and prepare offenders for treatment and future success in the community.





















