NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE PROPOSED NEW PROPERTY LINE FOR A LOT LINE ADJUSTMENT ON LOT 4. I FOUND THE MONUMENTS AS SHOWN ON THIS MAP. I HELD THE IRON RODS FOUND ON THE LINE BETWEEN LOTS 4 AND 5 FOR BEARINGS AND COMPUTED THE NEW LINE TO FIT THE REQUESTED OFFSETS TO THE EXISTING HOMES. FROM THIS I SET THE MONUMENTS AS SHOWN. THE CABLE TV COMPANY DESTROYED THE NORTHEAST CORNER OF LOT 4 WHICH I REPLACED HOLDING THE PLAT BEARING AND DISTANCES AND THE ANGLE FROM THE WESTERLY LINE OF LOT 4.
