Dear Commissioners,

My name is Katharine Yablonsky, I am the SUN Community School Coordinator at HB Lee Middle School. I am writing to express my deep concerns about the proposed cut to programs that protect and support our children. The proposed cut to the Gang Prevention Network mean that hundreds of gang affected youth throughout Multnomah County will not have access to prevention services and support that would help them stay in school, increase pro-social and employment skills, referrals to mental health, mentoring and services that detour them from entering the juvenile justice system.

The proposed cut will not just have an impact on the youth receiving the services, but also on the community as a whole. The Gang Prevention Network's services currently helps keep hundreds of gang affected youth from committing crimes in our neighborhoods by helping them return to school and get connected to employment programs. Many parents will also be left without support from programs that help them understand and reconnect with their youth; increasing the number of unhealthy families in our communities.

Here at HB Lee Middle School, the students greatly benefit from the gang prevention services. As a part of our SUN Community School, several Gang Prevention Specialists from El Programa Hispano lead mentoring groups and provide special opportunities for the students. The support the students receive through these services is essential to their healthy development. The mentors provide healthy role models for the students, as well as educate them on the risks of the gang life. The community at HB Lee would be greatly impacted and very devastated to lose the Gang Prevention services. I strongly support the retention of this valuable program.

I understand that balancing the budget this year is a great challenge, but I urge you to continue to support the funding for the Gang Prevention Services.
