- I. Recommendation/Action Requested: Requesting approval of an Order to realign Lower Rocky Point Road. This Order includes establishing the realigned portion as a County road, and vacating the abandoned portion of existing County road.

As upland owner, Multnomah County has rights to an additional strip of submerged land. Multnomah County has no use for the submerged land at this time nor do we plan to use it in the future. This County Road is dividing the lot now functioning as a marina making expansion of this business difficult. Our office is in receipt of a petition to vacate a portion of Lower Rocky Point Road. The adjacent landowners (marina) have proposed to dedicate property to be used as a vehicle turnaround, as well as provide an easement for a hiking trail along the riverbank. Expansion of the marina, including public hiking trails and a boat ramp appears to be to the benefit of the public. With approval of this Order, the road will end in a cul-de-sac, rather than continuing to the river with no turnaround right-of-way. We view this proposal as an opportunity to work cooperatively with the community to improve public facilities as well as encourage small business.

- III. Financial Impact: This proposal will have little or no financial impact for the County. Property vacated as right-of-way and returned to the tax rolls will be replaced with property dedication. Multnomah County has leased the submerged land from the State and sublet to the marina for many years, and at this time the lease is up, we must either renew the lease or forfeit rights, or vacate the property associated with riparian rights. The lease is currently \$518 per year and there has been no profit in leasing and subletting this small submerged property. We have consulted the Parks Division and they have no use for this land either. The marina has offered a fair trade, including the hiking trail/greenspace and a more effective turn around area for traffic.
- IV. Legal Issues: County Counsel has reviewed this Order and finds no adverse legal issues. ORS 368.126 allows vacation to be effective on identification of those parts to be abandoned in the order establishing the new road when the new road follows the same general alignment as the previous road.
- V. CONTROVERSIAL ISSUES: There are no controversial issues involved with this request.
- VI. Link to Current County Policies: The Multnomah County Transportation Division is cooperative with private business working to enhance public facilities.
- VII. Citizen Participation: The adjacent landowners have petitioned the County to relocate Rocky Point Road.
- VIII. Other Government Participation: The Division of State Lands has participated with Multnomah County in coming to a mutually satisfying decision about the State managed riparian land.

I. Recommendation/Action Requested:

Approve Board Order authorizing the advance distribution of property tax levies that are \$35,000 or less.

II. Background/Analysis:

Under ORS 311.392, the County is authorized to pay, in advance, the total property tax levies less the 3% discount to districts if it is more economical to do so.

The County has historically used the provision to advance pay districts. Since 1988 the cut established amount was \$25,000 or less. We have determined that it is more efficient to pay all districts with a levy of \$35,000 or less rather than maintain separate accounts for each district for the next 9 to ten years.

This advance payment impacts 22 districts. The total levy amount of \$182,931 is reduced by \$5,489 (3% discount) for a total advance of \$177,442.

III. Financial Impact: No financial impact to the County. The \$177,442 property tax advance will be collected by the County.

The Health Department, Dental Division is requesting approval of an exemption from the formal competitive bid process to purchase used dental equipment for the North Portland Dental Clinic.

II. Background/Analysis:

The Health Department recently negotiated a lease with an existing dental clinic on North Lombard in Portland. The dentist who currently occupies this space is willing to sell the majority of the equipment in the facility. The equipment has been appraised and is well below the appraisal value for the equipment. The used equipment is estimated to have 10 years of service value.

The cost to purchase the listed equipment new is approximately \$40,000. The cost for the used equipment is \$12,325.

The equipment is in good working order and has been appraised for the amount of the purchase by an independent appraiser. Since the equipment is already installed in the building, it provides a cost savings and will enable the Dental Clinic to deliver services to patients without delay.

I. Financial Impact:

The purchase of the used equipment will save approximately \$27,675. The Health Department has funds in the FY 94-95 budget to purchase the dental equipment.



2. **The exemption will result in substantial cost savings to the County.**


