Attached in an APR and resolution for the subject. It is a Title III requirement that we get the board to approve the Title III project expenses that relate to special Search and Rescue activities performed by MCSO on or adjacent to Federal Forest Lands. As described in the APR, the resolution accomplished two things: it authorized specific County expenditures to be eligible for Title III funding for the past fiscal year FY2011 and also pre-approves projects for the new fiscal year FY2012. This formality is very similar to the resolutions we have executed over the past four years making us eligible to receive National Forest related payments under the 2008 Secure Rural Schools and Community Self-Determination Act (aka SRS 2008) We received about \$119K in Title III safety net payments for these activities in the County's 2011 fiscal year as compared to the reduced funding of \$39K for the same activities scheduled in FY2012. Note that FY2012 will be the sunset year for this funding stream unless Congress extends this further.

The APR has been signed by Mindy Harris per arrangement with the DCM Director. If you have any questions, please let me know.
