RE: SALE OF TWO UNOCCUPIED GRAVE SITES AT MULTNOMAH PIONEER CEMETERY

By letter dated November 27, 1987, Charles Cieko, Parks Superintendent, informed you that the State Department of Transportation wished to purchase two (2) unoccupied grave sites at Multnomah Pioneer Cemetery, and went on to describe the method by which the purchase could be accomplished.

He also said that the order for the sale of the land to the State would be scheduled for your consideration on January 14, 1988, the date set for the public hearing to allow the sites to be used for "other purposes."

Preparation of the necessary paperwork to present to the Board the proposed sale plus a temporary construction easement on the Cemetery land along S.E. 82nd Avenue was my responsibility. However, due to my recent illness and absence from work for two weeks, I was not able to complete the paperwork in time to present it on January 14.

It will be forthcoming on either January 21 or January 28.

The additional appropriate proposed order allowing the new use and sale will also be scheduled for your consideration on January 14, 1988.

WHEREAS, ORS 97.440 allows dedicated cemetery's to be used for "other purposes", only after a public hearing and order of the Board of County Commissioners,


