SPECIFIC ISSUE: The Board should adopt the recommendation of the PC. Had the County rezoned the quarry and surrounding properties 10 years ago, the conflicting rural residential uses would not have developed. But the County did not, and now there is a substantial rural residential community surrounding the quarry. Conflicts will abound if the quarry is expanded, and the County will be charged with a complicated and staff-intensive monitoring and enforcement responsibility for many years to come. The Board cannot turn back the hands of time, but must adopt a policy position and a new Goal 5 analysis that reflects the current reality of what is on the ground. The conflicts analysis under Goal 5 is, and should be different now, and that is precisely the analysis adopted by the PC. This quarry has operated at 5,000 cy per year for over 10 years, and it should not be allowed to expand beyond that level to the detriment of the community.

If protection passes we lose

If protection fails we lose

After all this effort and I do mean Effort this is the best summation I can offer.

I spy 2 large causes for this failure, each with a bevy of reasons:

First

The situation is defined by a complex maze of zonings, anagrams, codes, requirements, restrictions, departments, committees, boards, and laws. The verbiage connected is not readily understood, something of a secret language, which, to the uninitiated seems a bait and switch shrouded in gobbledygook. This does not resolve conflict but inflame an already adversarial relationship and further divide us, as contestants. For commoners it makes articulating what you know to be true, cumbersome and convoluted, for the initiated it looks like a weapon to confuse and cloud reason. Now I fully support the process brought to bear on this problem, and I respect the many land use restrictions placed on us all, however, I must say that during this process I have seen many, many people alienated by the feeling that no matter what was said it meant nothing. It does not seem to be a language and process that easily brings us to the table of mutuality.

The dialogue is further thwarted by the fact that the regulations don't seem to allow us to have a conversation around economies of scale.

Protection for this quarry is like killing ants with landmines

The sheer volume of increased activity is staggering. The disruption caused by road repairs and improvements is daunting, huge increases in the amount of truck traffic presents many safety and livability issues, land values are seriously threatened, risks to other surrounding businesses is real and tangible, reduction of our local value to visitors is avidly stated by said visitors, and it presents serious increases in the demands placed on our community to provide hwy and personal safety. And then there are the all important and nearly impossible tasks of control, oversight and mitigation.

Denying protection is like trying to control an airliner with a fly swatter. The disruption caused by the lack of road repairs, the speeding, furtive traffic, the threat to property values and other local businesses, the alienation of visitors, the demands on our fire and rescue resources, and of course the total lack of oversight, control and mitigation.

Which brings me to the second area that has caused such failure. There was a time when there was a more lukewarm reaction to expanding the quarry but as time has past the behavior of the present owner and operator has served to make all the possible problems painfully obvious to most involved and thus have totally squandered any goodwill we felt. Their inability to abide by the simple regulations and limits already in place seems more like an absolute unwillingness and

is an affront to the place they take in the community. Their failure to control truck traffic ⁶⁹⁵ until we held a meeting with the sheriff's office, their complete lack of interest in maintaining ⁵⁸⁸¹ the legal limit of the quantities quarried, their unwillingness to provide us with any gravel at all, even though the production of gravel had proven a profit in all the previous years, and their constant effort to twist testimony through litigation have all resulted in a continuing resistance to awarding them protection. They personally have proven to be unwelcome neighbors. We don't get jobs nor gravel and the cost to the larger community are enormous and yet they persist.

I contend that until we are shown some respect, until they can be truly controlled and regulated and until we can have a discussion of an economy of scale we will consistently lose on every front. Most are so fed up they just want the whole thing shut down even though they realize the importance of this resource to ourselves and the greater Portland area. At least if it is closed we won't be stuck with policing ourselves an errant situation with no possibility of a win. With no protection in place it may be that our job might be easier.
