

A TRACT OF LAND IN NE 1/4 OF SEC 34, 1N 2E, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN NORTH LINE OF NE GLISAN ST. WHICH IS 40 FEET N AND 281.04 FEET E OF CENTER OF ABOVE SEC 34; THENCE N PARALLEL WITH N AND S CENTER LINE OF SAID SEC 34 A DISTANCE OF 310 FEET; THENCE E 28.96 FEET, THENCE S PARALLEL WITH ABOVE N AND S CENTER LINE, 310 FEET TO N LINE OF NE GLISAN ST., THENCE W 28.96 FEET TO POINT OF BEGINNING.
