

BEFORE THE BOARD OF COUNTY COMMISSIONERS
FOR MULTNOMAH COUNTY, OREGON

ORDINANCE NO. 394

An Ordinance amending the Multnomah County Comprehensive Framework Plan Findings Section and Policy Section adopted October 1977 and revised in June 1980.

SECTION 1. FINDINGS.

- A. The Board of County Commissioners finds that the Comprehensive Framework Plan adopted in October 1977 and amended in June 1980 requires periodic evaluation and updating as specified in Comprehensive Framework Plan Policy #1, Plan Relationships Policy.
- B. The Board further finds that the current update process has been the subject of: two years of ongoing work by the staff of the Division of Planning and Development; public meetings including Citizen Planning Groups and the general public and; review by Federal, State, local and special purpose government agencies and special interest groups.
- C. The Board further finds that by the document entitled, Multnomah County Comprehensive Framework Plan Update LCDC Goal Compliance Section, consideration has been given relating the Comprehensive Framework Plan amendments to the Land Conservation and Development Planning Goals applicable in Multnomah County.
- D. The Board takes notice that the Multnomah County Planning Commission has, by Resolution PC 23-81, recommended adoption of revisions to the Comprehensive Framework Plan.

SECTION 2. Section 3 of this Ordinance is added to and made a part of MCC Chapter 11.10.

SECTION 3. AMENDMENT.

The Multnomah County Comprehensive Framework adopted under MCC 11.10.200 is amended to incorporate the provisions of the documents entitled "Multnomah County Comprehensive Framework Plan Update Volume I Findings", "Multnomah County Comprehensive Framework Plan Update Volume II-Policies", "Amendments to the Comprehensive Framework Update Volume II", "Exceptions Statement to Goal 3 for Multnomah County's Framework Plan Update - 1983", "Exceptions Statement to Goal 4 for Multnomah County's Framework Plan Update - 1983" and Multnomah County Comprehensive Framework Plan Update, LCDC Goal Compliance Section".


SECTION 4. ADOPTION.

This Ordinance being necessary for the health, safety and general welfare of the people of Multnomah County, shall take effect on the thirtieth day after its adoption pursuant to Section 5.50 of the Charter of Multnomah County.

ADOPTED this 13th day of September, 1983, being the date of its second reading before the Board of County Commissioners of Multnomah County, Oregon.


