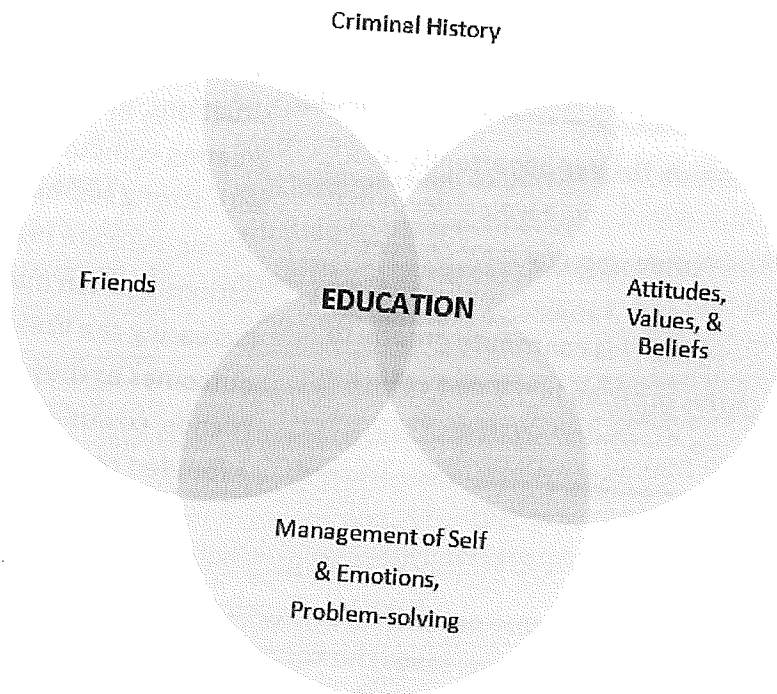

of corrections is for people to abide by the community's laws, and stop the cycle of re-incarceration. For this to happen, offenders need to make changes in their thinking and behavior. Education is the foundation essential to lasting change.

To make the most of limited funds, DCJ has used the List of Criminogenic Factors for guidance in priorities. The focus is on offenders who have a Moderate to High Risk of Re-offending, with a priority on the "Big Four" factors: History of Anti-Social Behavior, Anti-Social Cognition (Attitudes, Values, and Anti-social Personality (Management of Self & Emotions, Problem-Solving), and Anti-social Associates. The Change Center (through the services of Londer Learning Center) has a long-standing history of working with high risk clients, thus reflecting the composition of clients served by the Department of Justice.

Education is the foundation for Cognitive Behavioral Therapy. Education is not only a static factor that you have/have not achieved a high level of education is a dynamic factor that is influenced by the "Big Four" factors.

Research, as well as a wealth of information from staff within DCJ, and this Education and Cognitive Behavioral Therapy combination can result in a powerful synergy for significant life change.

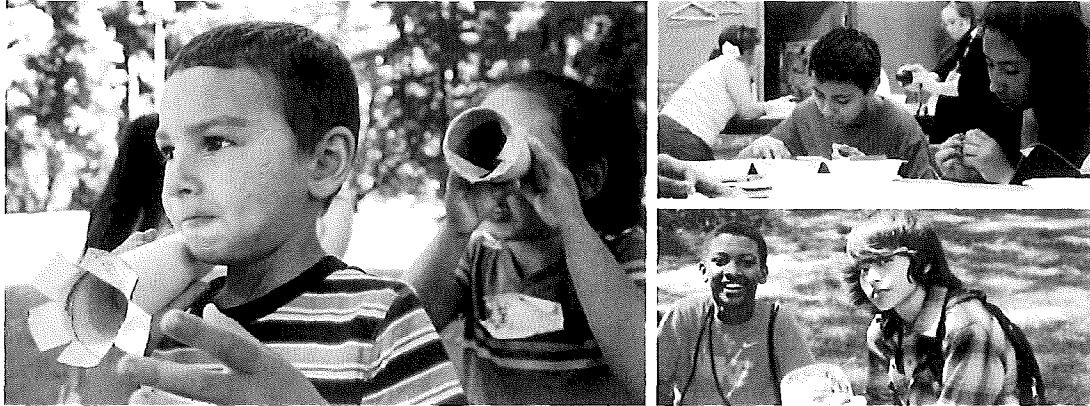

Realign NAYA's SUN funding with the missions of both Multnomah County and NAYA by serving Native American youth throughout Multnomah County schools:

- Restore \$217,000 that was cut from NAYA's FY 2017 SUN Youth Advocacy (SYA) Program.
- Allow expanded service to K-12 students. Do not limit to grades 5-10.

Background:

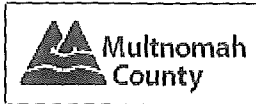
Multnomah County leadership worked in partnership with the Coalition of Communities of Color to make an equity-driven systemic shift within the SUN System in FY 2017 to prioritize communities of color. During that restructure, a new data driven formula was created to guide funding distribution decisions. From a high level view, NAYA received nearly the same amount of SUN funding as previous years. However, a deeper assessment of the entire SUN allocation shows a drastic impact in Native youth who are no longer engaging in academic and life support services, and at the same time an increase for NAYA in areas that are not necessarily mission-aligned.

Our practice-based evidence shows that the Native community is too spread out across Multnomah County to be effectively served in just the SUN Community Schools program (#25145). NAYA received funding for SUN Schools and was assigned Lynch Wood and Lynch View schools. There are very few Native American students in these schools. While we recognize the great need to serve any student with needs, NAYA is being forced to divert our already limited resources to off-site SUN Schools. As a result, we are serving substantially fewer members of the Native American community. We request realignment of SUN funding in order to best serve Native students wherever they are located.

Historically, our Native American community has been drastically undercounted in our local and national census. This misrepresented data has led to continued systemic oppression of Native families in need of services.

Impacts of the FY 2017 Budget Cuts to Youth Advocacy:

Oregon Program Snapshot

Community-Based: Assertive Community Treatment (ACT)

GRESHAM, OR—TELECARE ACT OREGON: Opened in 2007, Telecare ACT Oregon is a fidelity ACT program in Gresham serving 125 adult residents (ages 18-59) of Multnomah County with serious mental illness and who may be at risk for hospitalization, have had criminal justice involvement, or who have not been successful with traditional mental health programs. Services at the program include (but are not limited to) outreach and engagement, community-based wraparound services, intensive case management, housing support, medication support and education, dual diagnosis treatment, vocational and educational services, peer support services and linkage to financial benefits. It is funded by Multnomah County Healthshare and Family Care.

Crisis: Residential

PORTLAND, OR—MULTNOMAH CRISIS ASSESSMENT & TREATMENT CENTER (CATC): Opened in 2011, the CATC is a secure 16-bed, 24/7 crisis residential program in Portland serving adult (ages 18+) residents of Multnomah County with serious mental illness. The CATC serves approximately 650 individuals annually and is funded by Multnomah County.

Longer-Term Recovery: Secure Residential

BEND, OR—DESCHUTES RECOVERY CENTER: Opened in 2011, Deschutes Recovery Center is a 16-bed Secure Residential Treatment Facility (SRTF) in Bend serving adults (ages 18+) with an Axis I diagnosis. The main purpose of the program is to provide a stable living environment for people who are transitioning from the state hospital or other secure facilities to a community-based program as a primary component of their mental health treatment. Deschutes Recovery provides services to both Psychiatric Security Review Board (PSRB) and non-PSRB residents and is the only SRTF serving clients in Central Oregon. It is funded by the State of Oregon through Medicaid and other state funding.

PORTLAND, OR—72ND AVE. RECOVERY CENTER: Opened in 2005, this recovery center serves adult males (ages 18+) with a primary Axis I diagnosis and who have had extensive institutional experiences. It is funded by Oregon Health Systems Division, Medicaid, Medicare, and private pay.

GRESHAM, OR—RECOVERY CENTER AT GRESHAM: Opened in 2002, Recovery Center at Gresham is a 16-bed Post-Acute Intermediate Treatment Services (PAITS) program in Gresham serving adults (ages 18+) with a serious mental illness who may be under civil commitment or guardianship. The program was created to help divert individuals from state hospitals, avoiding unnecessary admissions, stabilize psychiatric symptoms that prevent people from being placed in less restrictive environments, reduce length of stay relative to state hospital stays, and discharge residents into community placements and lower levels of care rather than state hospitals. It is funded by the State of Oregon.

Testimony to Board of County Commissioners

May 10, 2017

Chair Kafoury and Multnomah County Commissioners

Thank you for the opportunity to testify on the County budget. I am Lisa Naito of Naito Public Affairs and testifying on behalf of Telecare Corporation. Telecare is an employee and family owned company that is one of the largest providers of mental health services in the country, operating for over 50 years. In Oregon, Telecare operates a number of programs under the leadership of Kevin McChesney, the Regional Operational Director for Oregon. For your information, I am attaching a Snapshot of Telecare's programs in Oregon. In addition to the Assertive Community Treatment Team in Gresham, three of the residential programs are located here in Multnomah County. Today's testimony is on behalf of the Crisis Assessment and Treatment Program or CATC, which has provided stabilization services for people in crisis for Multnomah County since 2011.

Following the death of James Chasse in police custody in 2006, a need for services was identified by Multnomah County and the City of Portland for people experiencing a mental health crisis or stepping down from acute care hospital stays to a community setting. This led to the opening of the CATC in 2011 under an rfp process. Funding for the program has historically been provided by Multnomah County, although the City of Portland shared in the costs at one point until a negotiation was reached between the two jurisdictions as to the responsibility for the CATC as well as other programs.

Multnomah County and Telecare have reason to be proud of the services at the CATC. The CATC offers a safe and nurturing place for people experiencing a mental health crisis, such as people who are at risk of suicide. The CATC offers services to stabilize the client, treat their illness and assist them in finding stable housing. The target length of stay is 6 days. Multnomah County and the City of Portland had the foresight to build this program, which is a best practice model and has proven to be successful in reducing costly hospitalizations and incarceration of people suffering from mental illness.

The CATC was not designed to meet the need of a drop off center available to the police, and that need led to the development and opening of the Unity Center in January, 2017. Now that the Unity Center is fully operational, it is anticipated that it will replace emergency departments as the heaviest referrer to the CATC.

Good evening Chair Kafoury, Commissioners. My name is Jesus Adan Torralba. I work for Latino Network's CHI Program, and I am here in support of the Community Healing Initiative, a project funded through Multnomah County Mental Health Department of Community Justice. This is a partnership between Latino Network, DCJ, Juvenile Services Division, and POIC.

This project helps reduce youth violence by addressing the root causes of violence in our communities by meeting the families where they are, usually in crisis when they come to us and eliminating barriers to their success one step at a time, all the while building on the strengths of the youth and families, while eliminating barriers.

Unfortunately my coworker Rudy Rolon who was originally going to speak today was not able to make it out, on his behalf I'd like to express his thanks for providing the opportunity to work as a mentor with youth and families in the community. I also would like to thank you Chair Kafoury, commissioners from the bottom of my heart for this amazing opportunity to be a brother/father/friend/mentor for youths in my community, the same community I grew up in. Growing up I had a lot of mentors supporting me in my life, that challenged my way of thinking, who always kept me involved in activities with others peers, supported my dreams of becoming an artist and that it's okay to pursue what I'm passionate in. These mentors opened my eyes to my culture, my identity, my humanity. Mentors that I now have the honor to call my coworkers and more importantly my brothers. These Mentors planted a seed of hope in my mind and my heart. That's why I do the work I do now, because one day someone decided that I was worth their time, that I was worth investing in when others stopped. I stand here before you as a servant, I'm here to help heal our communities and guide the next generation like Daniel Valdovinos.

We are here tonight to say thank you. Despite some cuts to the CHI budget, we want you to know that we are grateful to our partners in DCJ and the county for your continued support. We know this year is hard on everyone, no less on you who have to make the difficult choices of where you will invest when the community has many needs and there aren't sufficient funds to cover all of those needs. Good evening, my name is Johana Nava-Marin I attend Lent school and I am here representing Latino Network. Latino Network is a program that helps latino families and youth reach their full potential. Jesus Julian is the coordinator of conexiones at my school. Conexiones is a program for latino students after school, it is a program that teaches us about our culture and things that we wouldn't be taught in school. It helps us learn in different ways and about different things.

conexiones makes sure we are able to succeed by giving us opportunities and preparing us for our futures. Some of the activities we've had include; having career exploration classes, taking us to Oregon National Primate research center, taking us to the oregon capitol building and talking to a representative, taking us to kaiser permanente and many other things. It gives us the opportunity to meet new people, see new places and experience new things. All these experiences keeps us on track and helps us think about our future. Were latinos and we have so many struggles but we're not alone, we have conexiones.

Jesus Julian is our coordinator for conexiones and has helped me a lot in the past year. He checks in with us to see how our grades are and how we've been in school. But most importantly he checks in with us to see how we are, how we're feeling and how things are at home to makes sure we're on the right path. He has been there for us when no other teacher has, he has listened to us when no teacher or principal would and has helped us to find a solution when no one would. When principals, senior directors or teachers wouldn't be there for us and listen he would.

For these reasons Latino Network should keep providing program in our schools for future generations to help Latino families and kids find the right help they need to move forward.

Good evening Chair Kafoury, Commissioners.

My name is Neida Gomez. I am an eighth grader at Lent School. I have been a student at Lent for two years. In those two years I have been able to attend and participate in Conexions, a program provided through Latino Network. This experience has broadened my mindset to many different subjects, including culture, career paths, community service, and much more. Our group coordinator Jesus Julian is a great advocate, teacher and friend.

In connections we learn about our Latino culture. We speak of the different parts of Latin America from which we originated. We talk about the things that make that place unique compared to other parts of the world, the characteristics of people that originate from there, and the problems they face in those parts of the world. We also have discussions about how we can help improve the vision that others have of the Latino community. Lately we have talked about the different obstacles facing Latino communities and the things we can do to make it easier to overcome these obstacles.

Secondly, Connexions provides a place where you can go after school and learn about many different subjects. For example recently we had a unit where we learned about different career paths. In this unit we explored the different things we can pursue in life. We also talked about the things we would have to do in order to get to the jobs we want to have. Just recently we took a field trip to the Oregon National Primate Research Center. This field trip was one that I will never forget, not only because we had the chance to see cute little monkeys, but also because it gave me a different perspective on testing medicine on apes. It helped me understand that in order for it to be safe to test medicine on humans we have to test it through monkeys first. In addition I learned that human genes are 98% the same with chimps. This makes chimps a perfect animal to test our medicine on. I also learned about the different laws that are imposed to protect the chimps when they are being used as test subjects.

Currently we are on our community service unit. In this unit we have talked about the different problems our community is facing, and how these problems tie back to the Latin Culture and specifically problems the Latino community faces. Our class decided that our community is affected by homelessness. We will be going to downtown Portland on June second to feed, hopefully, 100 homeless people. In my opinion this is a great experience. This will allow us to see first hand what homeless people have to go through on a daily basis. I believe this will help us because it will encourage us to help out in our community more often in the future.

To sum up, Connexions is a place where students go to learn more about their culture, career options, how to help in their community and much more. Connexions is somewhere where we can go instead of being on the streets, and participating in criminal activity. For these reasons I'm telling you to NOT cut the budget for Connexions.

Me llamo Neida Gómez. Soy un estudiante de octavo grado en la Escuela de Lent. He sido estudiante en Lent por dos años. En estos dos años he podido asistir y participar en Conexiones, un programa proporcionado a través de Latino Network. Esta experiencia ha ampliado mi mentalidad a muchos temas diferentes, incluyendo cultura, planes para el futuro, servicio comunitario y mucho más. Nuestro coordinador de grupo Jesús Julián es un gran advicante, maestro y amigo.

En conexiones aprendemos sobre nuestra cultura latina. Hablamos de las diferentes partes de Latinoamérica de las cuales originamos. Platicamos de las cosas que hacen ese lugar único en comparación a otras partes del mundo, de las características de personas que originan de allí, y de los problemas que enfrentan en esas partes del mundo. También tenemos conversaciones sobre cómo podemos ayudar a mejorar la visión que otros tienen sobre la comunidad latina. Últimamente hemos hablado de los diferentes obstáculos que enfrentan las comunidades latinas y de las cosas que podemos hacer para hacer más fácil superar estos obstáculos.

En segundo lugar, Connexions proporciona un lugar donde se puede ir después de la escuela y aprender sobre diferentes temas. Por ejemplo, recientemente tuvimos una unidad donde aprendimos sobre diferentes trayectorias profesionales. En esta unidad exploramos las diferentes cosas que podemos seguir en la vida. También hablamos de las cosas que tendríamos que hacer para llegar a los puestos de trabajo que queremos tener. Recientemente hicimos una excursión al Centro Nacional de Investigación de Primates de Oregon. Este campo era uno que nunca olvidaré. No sólo porque tuvimos la oportunidad de ver monos lindos, sino también porque me dio una perspectiva diferente en la prueba de la medicina en monos. Me ayudó a entender que para que sea seguro probar la medicina en seres humanos tenemos que probarlo a través de los monos primero. Además aprendí que los genes humanos son 98% iguales con los chimpancés. Esto hace que los chimpancés sean un animal perfecto para probar nuestra medicina. También aprendí acerca de las diferentes leyes que se imponen para proteger a los chimpancés cuando se utilizan como sujetos de prueba.

Actualmente estamos en nuestra unidad de servicio comunitario. En esta unidad hemos hablado de los diferentes problemas que enfrenta nuestra comunidad. Cómo se relacionan estos problemas con la cultura latina y específicamente cuáles problemas enfrentan en la comunidad latina. Nuestra clase decidió que nuestra comunidad se ve afectada por la falta de vivienda. Iremos a Down Town el segundo de junio para alimentar, a 100 personas sin hogar. En mi opinión, esta es una gran experiencia. Esto nos permitirá ver de primera mano lo que los desamparados tienen que pasar diariamente. Creo que esto nos ayudará porque nos animará a ayudar en nuestra comunidad con más frecuencia en el futuro.

En resumen, Connexions es un lugar donde los estudiantes van a aprender más sobre su cultura, opciones de carrera, cómo ayudar en su comunidad y mucho más. Conexiones proporciona un lugar donde puedes ir en lugar de estar en la calle, y participar en actividades criminales. Por estas razones estoy diciendo que no recortar el presupuestos de Connexions.

This program helps us explore our career paths and gives us tools to get to our desire job. We went on many field trips like PSU, Oregon Primate Research Center, Kaiser permanente and one of my favorites, The Capital and talked to representatives. Conexiones gives you the opportunity and hands on experiences you wouldn't experience anywhere else.

This program gives you hope and chances to reach your full capacity. Latino network is more than just a non profit organization. It creates a community where we can all come together and become a whole. And for these reasons I ask to keep funding Latino network because it will help more than just one kid just like it has helped me.
