At the Conclusion of this Hearing, the Board Options are to Uphold the Merit System Civil Service Council Decision; Overturn the Decision; or Remand the Case for Further Proceedings. COUNTY ATTORNEY KATHRYN EXPLANATION OF CASE AND RESPONSE TO QUESTION OF CHAIR STEIN REGARDING RULE 175 WHICH WAS DRAFTED BUT NOT ADOPTED AT THE TIME OF THE , ADVISING THE MERIT COUNCIL NOT EMPOWERED TO HIRE A NEW HEARINGS OFFICER FOR ANOTHER HEARING. MS. SHORT EXPLAINED THE COUNCIL RULED 2-1 AGAINST, THAT'S WHY IT HAS BEEN BROUGHT BEFORE THE BOARD. ROBERT SNEE RULE 175 WAS NOT IN PLACE IN JUNE, FEELS NOT APPLICABLE AND DOES NOT ADDRESS THE ISSUE, FEELS CLEAR APPEAL TO MERIT COUNCIL ALLOWS MERIT COUNCIL OR HEARINGS OFFICER APPEAL. IN RESPONSE TO A QUESTION OF CHAIR STEIN, MR. SNEE ADVISED NOT BEFORE A HEARINGS OFFICER BUT BEFORE THE MERIT COUNCIL - IF NOT FINISHED IN 90 MINUTES CAN COME BACK. MS. SHORT AGREES NOT CLEAR INTENTION - RULES ARE BEING CLARIFIED - COST ISSUE \$3,000 ALREADY SPENT - SHE CAN HAVE OPPORTUNITY - . COMMISSIONER CRUZ, AS A POLICY ISSUE, MS. SHORT'S POSITION MAKES SENSE, MR. SNEE'S POSITION SOUNDS LIKE AN APPEAL. NO APPELLANT REVIEW OF DECISION. POLICY CLEAR WHAT IS APPROPRIATE 135 AND 175 CAN BE FURTHER CLARIFIED - FEELS COMFORTABLE. FOLLOWING SUGGESTION OF MS. SHORT, COMMISSIONER CRUZ MOVED AND COMMISSIONER LINN SECONDED, APPROVAL OF PH-1. ROBERT SNEE. ORDER 00-174 UNANIMOUSLY APPROVED.

### **LAND USE PLANNING HEARING**

Chair Beverly Stein convened the meeting at 10:26 a.m., with Vice-Chair Serena Cruz and Commissioners Diane Linn and Lisa Naito present, and Commissioner Sharron Kelley excused.

**P-1 DE NOVO HEARING, TESTIMONY LIMITED TO 20 MINUTES PER SIDE Regarding the Hearings Officer Decision in Case CU 00-02, Denial of a Conditional Use Permit Application for Development Within Howell Territorial Park on Property Located at 13901 NW HOWELL ROAD, PORTLAND. Presentations by Planner Derrick Tokos, Hearings Officer Liz Fancher, and Regional Planner Lora Price, Representative of Applicant/Appellant Metro.**

CHAIR STEIN EXPLAINED QUASI-JUDICIAL PROCESS. AT CHAIR STEIN'S REQUEST FOR DISCLOSURE, NO EX PARTE CONTACTS WERE REPORTED. COMMISSIONER NAITO DISCLOSED THAT SHE IS FAMILIAR WITH THE SITE AS A RESULT OF HER TENURE AS A METRO COUNCILOR, BUT THAT HER DECISION WOULD NOT BE BIASED. AT CHAIR STEIN'S REQUEST FOR CHALLENGES AND/OR OBJECTIONS, NONE WERE OFFERED. COUNTY ATTORNEY SANDRA

DUFFY RESPONSE TO CHAIR STEIN QUESTION REGARDING ORDER OF PRESENTATION.

PLANNER TERRICK TOKOS PRESENTED CASE HISTORY, STAFF REPORT AND RECOMMENDATION OF DENIAL OF THE CONDITIONAL USE PERMIT BASED ON METRO'S FAILURE TO SHOW THAT PROPOSED PARK IMPROVEMENTS WILL NOT FORCE SIGNIFICANT CHANGE IN OR SIGNIFICANTLY INCREASE THE COSTS OF ACCEPTED FARM PRACTICES ON SURROUNDING FARMLAND; INTERFERE WITH SEASONAL HARVESTS AND CROP DELIVERY TO MARKET; CONFLICT WITH THE APPLICATION OF PESTICIDES AND HERBICIDES AS CURRENTLY PRACTICED ON ADJOINING FARMLAND; CREATE HAZARDOUS TRAFFIC CONDITIONS, AND REQUIRE PUBLIC AND FIRE SERVICES BEYOND WHAT EXISTS OR IS PROGRAMMED FOR THE AREA. MR. TOKOS RESPONDED TO QUESTIONS OF COMMISSIONER CRUZ REGARDING PUBLIC SAFETY ACCESS IMPROVEMENTS TO RIGHT TURN LANE AND FIRE SAFETY ISSUES FOR LARGE EVENTS.

HEARINGS OFFICER LIZ FANCHER PRESENTED CONDITIONS, FINDINGS OF FACT AND CRITERIA USED IN HER DETERMINATION TO DENY APPLICATION AND RESPONDED TO BOARD QUESTIONS CONCERNING ROAD SAFETY AND FARM USE.

METRO COUNCILOR ROD MONROE INTRODUCED CHARLES CIECKO, DICK MATTHEWS, KENNETH HELM AND GARY KATSION, AND PRESENTED TESTIMONY IN SUPPORT OF DEVELOPMENT OF A PARK WITH HANDICAP ACCESS AND THE ABILITY TO CONDUCT THREE LARGE EVENTS PER YEAR ON THE SITE. CHAIR STEIN ADVISED PARTIES TO ADDRESS THE LEGAL ISSUES, INCLUDING IMPACT OF THE PROPOSED DEVELOPMENT. DICK MATTHEWS OF THE OREGON HISTORICAL SOCIETY TESTIFIED IN SUPPORT OF THE DEVELOPMENT, ADVISING HE NEVER SAW A TRAFFIC PROBLEM DURING PREVIOUS TWO DAY WINTERING-IN FESTIVAL ATTENDED BY 6,000. IN RESPONSE TO A QUESTION OF CHAIR STEIN, MR. MATTHEWS ADVISED PARTICIPANTS PARKED IN TWO FIELDS. CHARLES CIECKO OF METRO PARKS TESTIFIED THAT MULTNOMAH COUNTY FAILED TO KEEP APPROPRIATE RECORDS WHEN OWNERSHIP AND RESPONSIBILITY OF COUNTY PARKS WAS TRANSFERRED TO METRO IN SEPTEMBER, 1994; THAT DURING THE 1996 METRO MASTER PLAN PUBLIC PROCESS NO NEGATIVE COMMENTS WERE SUBMITTED; THAT METRO SPENT THOUSANDS OF TAX DOLLARS OVER THE LAST THREE YEARS ON THIS ISSUE AND THAT HE IS FRUSTRATED BY COUNTY STAFF BLINDSIDING METRO BY TODAY'S RECOMMENDATION OF DENIAL. METRO ATTORNEY KENNETH HELM SUBMITTED OCTOBER 10, 2000 MEMO FROM LORA PRICE ADDRESSING NOXIOUS WEEDS IMPACT, FIRE SAFETY AND FARM CONCERNS, ADVISING THEY HAVE ALREADY SPRAYED ONCE AND WILL CONTINUE TO DO SO AS WEATHER ALLOWS. MR. HELM TESTIFIED IN SUPPORT OF GRANTING THE CONDITIONAL USE PERMIT, ADVISING THE THREE ANNUAL SPECIAL WEEKEND EVENTS WILL BRING IN NO MORE THAN

4,500 PARTICIPANTS, AND THAT METRO HAS AGREED TO COMPLY WITH ALL THE TRAFFIC IMPACT MITIGATION CONDITIONS. METRO TRAFFIC ENGINEER GARY KATSION OF KITTELSON AND ASSOCIATES, TESTIFIED IN SUPPORT OF CONDITIONAL USE PERMIT, ADVISING THE COUNTY STAFF REQUESTED MITIGATION IS NOT APPROPRIATE, AND THAT THE TRAFFIC INTERSECTION MEETS CAPACITY PER STATE LAW, AND NO SAFETY CODES WILL BE VIOLATED.

SAUVIE ISLAND RESIDENT MIKE MOAR PRESENTED TESTIMONY IN OPPOSITION TO CONDITIONAL USE PERMIT, CITING TRAFFIC CONCERNS AND DEGREATION OF OPEN LAND, FARM USE AND SCENIC WILDLIFE PROTECTION. LORA CRESWICK, REPRESENTING SAUVIE ISLAND BOOSTERS, PRESENTED TESTIMONY IN OPPOSITION TO CONDITIONAL USE PERMIT, ADVISING THE BOOSTERS URGE BOARD SUPPORT OF THE HEARINGS OFFICER DECISION TO DENY BASED ON THE RIGHTS OF THE RESIDENTS. MS. CRESWICK ADVISED SHE DISAGREES WITH TESTIMONY REGARDING FIRE RESPONSE TIME. MS. CRESWICK RESPONSE TO QUESTIONS OF COMMISSIONER LINN REGARDING INVOLVEMENT OF SAUVIE ISLAND GRANGE AND OTHER RESIDENTS, WHEN SHE BECAME AWARE OF THE PROPOSED EXPANSION (JUNE, 2000) AND TRAFFICE IMPACT TO THE SAUVIE ISLAND BRIDGE.

WITH NO REQUEST FOR CONTINUANCE OR OBJECTION TO HEARING, CHAIR STEIN CLOSED THE PUBLIC HEARING. MR. HELM AND MR. CIECKO OF METRO AND MR. TOKOS AND ED ABRAHAMSON OF MULTNOMAH COUNTY RESPONSE TO BOARD QUESTIONS ON ISSUES INCLUDING CODE PROVISION STANDARDS, PUBLIC INPUT ON MASTER PLAN, SAUVIE ISLAND OUTREACH, INTERSECTIONS ANALYSIS, FARM USE, TRAFFIC AND PARKING IMPACT, AND PROPOSED ADDITIONAL CONDITIONS. MR. HELM REQUESTED THAT THE RECORD BE LEFT OPEN FOR ONE WEEK IN ORDER TO RESPOND TO TRAFFIC ISSUES AND TO PROVIDE THE NAMES OF SIX SAUVIE ISLAND RESIDENTS WHO PARTICIPATED IN THE METRO MASTER PLAN. COMMISSIONER LINN ADVISED SHE WANTS TO BE RESPONSIVE TO SAUVIE ISLAND FARMERS AND OTHER RESIDENTS, BUT IS NOT COMFORTABLE UPHOLDING THE HEARINGS OFFICER DECISION TODAY. AT COMMISSIONER LINN'S SUGGESTION THAT METRO AND THE COUNTY AND APPROPRIATE SAUVIE ISLAND RESIDENTS GET TOGETHER TO COME UP WITH A COMPROMISE DECISION THAT IS ACCEPTABLE TO ALL, MR. HELM ADVISED THAT METRO WOULD DO SO AND WOULD THEREFORE WAIVE THE 150 DAY CLOCK TO A TIME CERTAIN OVER THE NEXT MONTH OR SO. AT THE REQUEST OF CHAIR STEIN, COMMISSIONER LINN MOVED AND COMMISSIONER NAITO SECONDED, TO CONTINUE THE DECISION TO THURSDAY, DECEMBER 7, 2000. COMMISSIONER CRUZ ADVISED SHE IS HAPPY TO SUPPORT THIS APPROACH, AND DEFENDED COUNTY STAFF, STATING THAT SHE HAS FOUND PLANNING STAFF TO BE HARD WORKING AND DEDICATED, JUST LIKE METRO STAFF, AND ADDED "WE ALL FIGHT FOR LAND USE LAWS EVERY DAY". CHAIR STEIN ADVISED SHE SUPPORTS THE MOTION AND HOPES WHEN THE PARTIES COME
