General Information

1. What action are you requesting from the Board?

Authorization for the Director of the Health Department to submit an application for \$60,000 to the Oregon Health Authority School-Based Health Center Program's Planning Grants funding opportunity.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Since 1986, MCHD's School-Based Health Center (SBHC) Program has been an integral part of the public health care delivery system as a main provider of comprehensive healthcare to uninsured school-aged youth and insured youth who cannot or chose not to access private providers (all school-aged youth are eligible for services including those attending schools without health centers, dropouts, and homeless). SBHC provide culturally sensitive and age appropriate health care, facilitate early detection of high risk behaviors and health issues, and reduce barriers to health care

by being conveniently located in schools and by providing confidential care in a safe environment.

East Multnomah County is seen as the most under-served area in the county because the region has the highest per capita number of school-age students but no school-based health centers. A 2009 SBHC Planning Grant used a series of focus groups, school board meetings, community-wide meetings, and steering committee meetings to determine where the first SBHC in East County should be located. Based on the community response, as well as data, Centennial High School was selected as the first SBHC site. Approximately 48% of Centennial School District students are racial or ethnic minorities, and 64% of students qualify for the Federal Free and Reduced Lunch Program. Results from the 2010 School Wellness Survey found that students in the Centennial School District are at greater risk than their peers across the state in many areas including, but not limited to tobacco, alcohol and drug use, depression, and academic failure.

To continue its progress toward constructing the Centennial High School SBHC, the Health Department is planning to apply for another SBHC Planning Grant to open a Community Resource Center in a room in Centennial High School that is adjacent to the area that will eventually house the SBHC. The Community Resource Center will contain brochures and information on social and health services available in the community, including County and community based programs. The room will also serve as a space for students and their families to meet with Centennial Student Services staff and health/social service providers, and provide a space to hold additional community forums about SBHC services and the proposed Centennial SBHC. The meetings and linkages to community resources provided by the Community Resource Center will be framed as an extension of the services to be provided by a potential SBHC and offer a venue to discuss health and social service needs. Grant funds will be used to install a wheelchair ramp to facilitate universal access to the Community Resource Center, cover cosmetic repair costs, obtain furniture, and fund the community forums.

3. Explain the fiscal impact (current year and ongoing).

This grant will provide the Health Department with \$60,000 for FY 2013.

4. Explain any legal and/or policy issues involved.

5. Explain any citizen and/or other government participation that has or will take place.

The Centennial School Board has already approved the addition of a SBHC at Centennial High School and the creation of the proposed Community Resource Center. Approval has also been obtained from community members and school boards throughout East County to focus on Centennial High School as the site of the first East County SBHC.
