Filling a Vacancy in the Oregon Legislative Assembly, House of Representatives, District 43

The Multnomah County Board of Commissioners Finds:


- a. Effective March 2, 2004, there is a vacancy in Oregon Legislative Assembly, House of Representatives, District 43 due to the resignation of State Representative Deborah Kafoury.
- b. Pursuant to state law, on March 13, 2004, the Democratic Party Precinct Committeepersons in the Oregon Legislative Assembly, House of Representatives, District 43, made nominations to fill the vacancy.
- c. The nominees chosen were: R.P. Joe Smith, JoAnn A. Bowman and Tom Markgraf.
- d. In accordance with procedures established by the Secretary of State, the Multnomah County Board of Commissioners considered the nominations at a public meeting on Thursday, March 25, 2004.
- d. At the conclusion of the public meeting the Commissioners voted to appoint R.P. Joe Smith to fill the vacancy, said nominee having received the highest number of votes on the second ballot as indicated on the vote tabulations attached as **Exhibit A and Exhibit B**.

The Multnomah County Board of Commissioners Resolves:

1. R.P. Joe Smith is selected as the appointee to fill the vacancy in the Oregon Legislative Assembly, House of Representatives, District 43.
2. This Resolution shall promptly be forwarded to the Secretary of State as required by ORS 171.060(3).
