Page one

A parcel of land, being all of Lot 32 of "ANDREWS ACRES" a duly recorded subdivision plat, and a portion of Lot 19 of "GERMANTOWN" a duly recorded subdivision plat. Said parcel is located in the S.E. 1/4 of Section 9, Township 1 North, Range 1 West, Williamette Meridian, Multnomah County, Oregon; according to survey made by M. David Viles, L.S. 2029, dated August 13, 1986 and recorded in above said county; being more particularly described as follows;

Beginning at a point on the Easterly line of above said "ANDREWS ACRES" and the Westerly line of above said "GERMANTOWN", which is the Southwesterly corner of Lot 8 and the Northwesterly corner of Lot 19 of above said "GERMANTOWN";

thence N74°47'20"E, 52.26' along the line between above said Lot 8 and Lot 19 of said "GERMANTOWN", to a point;

thence S00°15'00"E, 228.40' parallel to the West line of said "GERMANTOWN" to a 5/8 inch O.D. iron rod with yellow plastic cap marked "VILES, LS 2029", on the Easterly right-of-way line of county road number 1636;

thence N13°23'E, 297' along the line between Lot 32 and Lot 31 of said "ANDREWS ACRES" to a point;

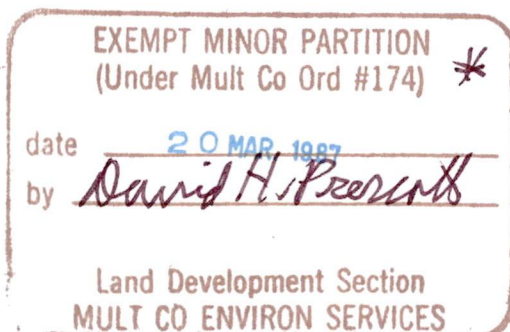

A parcel of land located in Lot 19 of "GERMANTOWN" a duly recorded subdivision plat in Multnomah county, being in the S.E. 1/4 of Section 9, Township 1 North, Range 1 West, Williamette Meridian, Multnomah county, Oregon; according to survey made by M. David Viles, L.S. 2029, dated August 13, 1986 and recorded in above said county; being more particularly described as follows:

Beginning at the Northeasterly corner of Lot 19 of above said "GERMANTOWN", which is S74°47'20"W, 18.99' from a 5/8 inch O.D. iron rod with yellow plastic cap marked "PLS 737 CASWELL" in center of creek, as set in C.S. 35815;

thence S00°15'E, 964.69' along the line between Lot 19 and Lot 18 of said "GERMANTOWN" to a point, which is the Southeasterly corner of Lot 19, the Southwesterly corner of Lot 18; the Northeasterly corner of Lot 20 of said "GERMANTOWN";

thence N42°57'E, 242.97' along the line between Lot 19 and Lot 20 of said "GERMANTOWN" to a point, which is the reentrant corner of Lot 19 of said "GERMANTOWN";

# BOUNDARY SURVEY

NARRATIVE: Purpose of the survey was a lot line adjustment between lot 32 of "ANDREWS ACRES" and lot 19 of "GERMANTOWN". After researching deeds and surveys of record, field work commenced on July 26, 1986 with crew consisting of myself, Linda; Andy Viles, Justin Copus; Tim Higgins. Equipment used: Kern one second theodolite and Citation E.D.M. I began at point <1> and ran random traverse along C.R. 1636, ending at point <17>, locating shown monuments. After finding those monuments to be within 0.08' of recorded distances (with noted exceptions), I fixed the line between the two said lots by holding point <8> and the record course and distance from point <20>. Then setting new corners on August 13, 1986. BASIS OF BEARINGS being C.S. 35815.

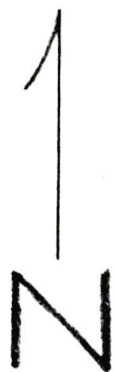
