## General Information

### 1. What action are you requesting from the Board?

Set a public hearing on November 15, 2012, for consideration of an order approving the annexation of a single parcel of land to Dunthorpe-Riverdale County Service District and direct that notice be provided of the hearing as required under applicable law and regulation.

### 2. Please provide sufficient background information for the Board and the public to understand this impacts the results.

Under ORS 198.857, a petition for annexation to a service district must be indorsed by the district board before it is filed with the county board. The Board of Dunthorpe-Riverdale County Service District approved and indorsed a petition to annex a single parcel of land (the Property) to the District under ORS 198.857 on October 18, 2012.

The indorsed petition meets the requirements of ORS 198.857 and the Principal Act and is now filed with the County Board; accordingly under the cited authority, this Board must now set this matter for a public hearing. A legal description of the Property is included in Exhibit 1 to the Agenda Placement Request for the Indorsement of the Petition.

## EXHIBIT "ONE"

A portion of Block 132, DUNTHORPE, a recorded subdivision in Multnomah and Clackamas Counties, Oregon, described as follows:

Beginning at a point in the Northerly right of way line of Iron Mountain Boulevard, a 60 foot right-of-way, 15 feet Northwesterly of the Southeast corner of Block 132; thence Northwesterly, along the Northerly line of Iron Mountain Boulevard, a distance of 155 feet; thence North  $50^{\circ}40'40''$  East 333 feet to a point on the Northerly line of Block 132 that is South  $35^{\circ}08'$  East 135 feet from the Northwest corner thereof; thence along said Northerly line of Block 132, South  $35^{\circ}08'$  East 100 feet; thence Southwesterly a distance of 334 feet to the place of beginning.
