It appearing that ORS 311.392 allows for the advance distribution of property tax monies from the County General Fund to taxing districts if, in the discretion of the County, it is more economical to do so.

THEREFORE IT IS ORDERED that the Director of Finance be authorized to distribute funds prior to January 5, 1998 in advance, to those various tax levying districts whose annual levies are \$50,000 or less for the fiscal year 1997-98. In addition, be ordered to deduct from the levy the 3 percent discount, which would have been given had all the taxes been paid by December 19.

IT IS FURTHER ORDERED that all taxes advanced by the County General Fund be reimbursed to the County General Fund when collected.
