Approval of government contract 201620.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Under the terms of this agreement with Metro, a regional government that serves Multnomah, Clackamas, and Washington counties, the Sheriff's Office provides one FTE detective to combat illegal dumping, flow control and solid waste enforcement. The detective in this unit has knowledge of applicable laws and ordinances and works to enforce these laws. This includes (but is not limited to): investigation and surveillance of companies that haul waste to determine if they are disposing of solid waste properly, investigation of incidents of illegal dumping, coordination of efforts to curtail problems and educate stakeholders with issues associated with solid waste, surveillance of chronic dump sites, and the coordination of the legal removal of chronic transient camps. This agreement affects MCSO Metro Services program offer 60074. The IGA is effective July 1, 2015 through June 30, 2016.

3. Explain the fiscal impact (current year and ongoing).

Metro agrees to compensate the County for providing this service in an amount not to exceed \$291,634.00. This revenue has been anticipated and is part of the FY16 budget.
