

SUBJECT: Executive Sessions - 1992 - Local 88

At our last executive session on November 21 dealing largely with Probation and Parole Officers, I spoke of both the complexity and potentially rocky nature of our reopener with Local 88 in 1992. The fiscal direction needed to follow up on the 1991 wage freeze, the future structure of our health and welfare system, and a variety of issues pent up over a four year period will be before the Board. In light of the fiscal importance of these negotiations and the potential complexity of certain of the issues, I suggested a set of executive sessions rather than a single marathon session in which all involved would be overwhelmed by the number of issues being discussed. This approach met with Board approval. Chair McCoy further suggested that these sessions be scheduled separately from regular Board sessions so that adequate time be allocated for discussion. To meet these needs the following dates and times have been scheduled with tentative topics as indicated:

- January 8 9:00 - 11:00 a.m. Drug and Alcohol Policy
- January 15 9:00 - 11:00 a.m. Wages and Benefits
- January 22 9:00 - 11:00 a.m. Other Issues and Follow-up on Prior Sessions

I trust the above sessions are adequate and will allow the Board full comprehension of all issues, an opportunity to ask all needed questions, and time for follow-up on issues which are found to be difficult.
