ORDINANCE NO. 389

An Ordinance establishing a Steering Committee to facilitate and coordinate the development of a Citizen's Congress for Multnomah County.

Multnomah County Ordains as follows:

Section 1. Policy and Purpose. The Board of County Commissioners finds that there is a need to provide for improved communication between Multnomah County and its citizens regarding the development of a mission statement for Multnomah County Government.

The Board of County Commissioners further finds that a Citizen's Congress developed under the direction of an impartial Steering Committee may be an effective way to facilitate such communication.

Section 2. Steering Committee. A Citizen's Congress Steering Committee is established as a Commission of Multnomah County government.

Section 3. Membership and Staff.

A. The Citizen's Congress Steering Committee shall consist of thirty-seven (37) members to be appointed by the County Executive and approved by the Board as follows:

1. A Representative of the Multnomah County Citizen Involvement Steering Committee;
2. A Representative of the Portland League of Women Voters;
3. A Representative of the East County League of Women Voters;
4. A Representative of the City Club of Portland;
5. A Representative of the Portland Chamber of Commerce;
6. A Representative of the Gresham Chamber of Commerce;
7. A Representative of Ecumenical Ministries of Oregon;
8. A Representative of Oregon Fair Share;
9. A Representative of the Office of Neighborhood Associations (City of Portland);
10. A Representative of the Urban League of Portland;
11. A Representative of the Grey Panthers;

12. A Representative of the Urban Indian Council;
13. A Representative of the Portland Town Council;
14. A Representative of Aguila;
15. A Representative of the Multnomah County Labor Council;
16. A Representative of an independent labor organization;
17. A Representative of the Center for Urban Education.
18. A Representative of Multnomah County Democratic Party Central Committee;
19. A Representative of Multnomah County Republican Party Central Committee;
20. A Representative of the National Association for the Advancement of Colored People (NAACP);
21. A Representative of Committee of Spanish Speaking People of Oregon (COSSPO);
22. Five (5) Citizens at Large;
23. A Representative of East County Coordinating Committee (ECCO);
24. A Representative of the Tri-County Youth Consortium;
25. A Representative of Mid-County Future Alternatives Committee;
26. A Representative of Enough is Enough In Oregon;
27. A Representative of Oregon Taxpayers Union;
28. A Representative of the Farm Bureau;
29. One Representative from each of the following Portland neighborhood association umbrella organizations:

Neighborhoods West/ Northwest
Neighbors North
Northeast Office
Southeast Uplift Office
Southwest Neighborhoods

- B. A Presiding Officer shall be selected by the Committee at its first meeting.
- C. Staff support shall be provided by the Citizen's Involvement Steering Committee and Staff of the Board of County Commissioners.

Section 4. Powers and Duties of the Committee.

- A. The Steering Committee shall first determine whether a Community Congress is the best alternative for improving citizen participation.
- B. If the Committee determines that a Community Congress is the best way for improving communication between Multnomah County and its citizens, then the Committee shall propose the number of appointees to the Congress and recommend a selection process for their appointment. Delegates are to be as broadly representative of the Citizenry of Multnomah County as possible. Opportunities for self nomination shall be provided.
- C. The Committee shall develop rules and procedures for adoption by the Citizen's Congress in order to facilitate a review of existing County programs and revenue sources, provide for the division into subcommittees in order to hear testimony and develop priority proposals, propose a mechanism for communicating the Congress' findings and concerns to the Board of County Commissioners.
- D. The Committee shall organize the Congress to focus solely on functional issues regarding the Mission of County Government. Structural considerations shall remain strictly under the Charter Review Commission.
- E. The Steering Committee shall select an acting Presiding Officer for the Citizen's Congress to serve until a permanent chair is duly elected.
- F. The Steering Committee shall recommend the dates and site of the Citizen's Congress.
- G. The Steering Committee shall present an initial report to the Board no later than October 18, 1983, prior to proceeding to organize the Community Congress.
- H. The Committee's final recommendations shall be made to the Board no later than December 1, 1983.
