The department is requesting board approval of budget modification DCA-05-15 reclassifying a Contract Technician to a Contract Specialist Senior.

This modification reflects a Class/Comp decision (#2452); a reclassification request initiated by management. The job tasks for this position have increased from contract processing and tracking to direct participation in the negotiation and drafting of new contracts, oversight on the most complex service and supply contracts, coordinating special projects involving inter-divisional and inter-agency agreements, and developing and monitoring complex proposals to ensure the alignment of contracts and funding sources to comply with the scope and schedule of the contract. The focus of this work will be on Information Technology contract administration. Class/Comp reviewed the submitted job duties and description and concluded that the Contract Specialist Senior was the best fit for the position. Program offer affected is 78045.

#### 3. Explain the fiscal impact (current year and ongoing).

Personnel expenses are expected to increase \$48,734 for FY15. This will be offset by a reduction in Temporary and Premium costs. Ongoing, the annual fiscal impact will be an increase of about

\$48,734 which will be absorbed with in the department's budget.
