**R-3 PUBLIC HEARING and Board Decision on Request for Reconsideration of Board Order No. 07-158 Denying Ric and Lee Ball's Appeal of ITAX Administrator's Final Determination**

COMMISSIONER COGEN MOVED AND COMMISSIONER ROBERTS SECONDED, APPROVAL OF R-3.

MINDY HARRIS AND JACQUELINE WEBER EXPLANATION, BACKGROUND OF RECONSIDERATION, DETAILS OF WHY THE BOARD DENIED THE BALL'S ORIGINAL APPEAL, ABOUT THEIR RESIDENCE AND WHY AND HOW THE BOARD VOTED. MS. WEBER EXPLAINED THAT EVEN THOUGH THE BOARD RECENTLY APPROVED ANOTHER TAXPAYER'S REQUEST FOR RECONSIDERATION, THERE IS NO PROVISION IN THE BOARD RULES FOR RECONSIDERATION HOWEVER THE

BOARD HAS THE AUTHORITY TO DO SO. THE BALLS WERE NOT PRESENT FOR THE HEARING.

COMMISSIONER COGEN COMMENTED THAT THE BALLS ARE ESSENTIALLY SAYING THAT BECAUSE THE BOARD APPROVED ANOTHER CASE THEY SHOULD RECONSIDER OUR DECISION. COMMISSIONER COGEN STATED THERE ARE NO NEW FACTS WHY OUR DECISION SHOULD CHANGE. COMMISSIONER ROBERTS STATED IF THE BOARD DID IT FOR ONE AND THE CIRCUMSTANCES ARE SIMILAR, THE BOARD SHOULD DO SO AGAIN. MS. WEBER ADVISED THERE ARE SOME SUBSTANTIAL DIFFERENCES BETWEEN THE RASK AND BALL APPEALS. COMMISSIONER ROJO STATED IT IS A FELONY TO VOTE IN A COUNTY YOU DO NOT LIVE IN AND IF WE ALLOWED A BREAK TO THE RASKS WE SHOULD ALLOW THE SAME FOR THE BALLS. COMMISSIONER ROJO ADVISED SHE WILL VOTE TO FORGIVE ONE-HALF OF THE ITAX THE BALLS OWE. COMMISSIONER COGEN ADVISED HE DISAGREES BECAUSE EACH CASE IS DIFFERENT AND SINCE THERE ARE NO NEW ALLEGATIONS AND FACTS IN THE BALL CASE, THE BOARD'S PREVIOUS DECISION SHOULD STAND. COMMISSIONER NAITO ADVISED SHE AGREES WITH COMMISSIONER COGEN. CHAIR WHEELER STATED THAT A HALLMARK OF TAX IS FAIRNESS AND TAX LAWS NEED TO BE APPLIED CONSISTENTLY. CHAIR WHEELER ADVISED HE DOES NOT INTEND TO CHANGE HIS ORIGINAL VOTE. COMMISSIONER ROBERTS ADVISED HE AGREES WITH COMMISSIONER ROJO. IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS, MS. WEBER EXPLAINED THAT A YES VOTE WOULD ALLOW RECONSIDERATION OF THE BALL APPEAL.

REQUEST FOR RECONSIDERATION FAILED, WITH COMMISSIONERS ROJO AND ROBERTS VOTING AYE, AND COMMISSIONERS NAITO, COGEN AND WHEELER VOTING NO. [2-3]
