WS-3 Health and Human Services Policy Panel: Prevention. Presented by Lillian Shirley and Joanne Fuller.

CHIEF OF STAFF JANA MCLELLAN INTRODUCTION AND LOGISTICS THE WORK SESSION. HEALTH DEPARTMENT DIRECTOR, LILLIAN SHIRLEY INTRODUCED THE PANEL OF SPEAKERS FOR THE PREVENTION MODEL SYSTEM.

CARLOS CRESPO, DIRECTOR, COMMUNITY HEALTH, PORTLAND STATE UNIVERSITY, DAVID REBANAL, PROGRAM OFFICER OF THE NW HEALTH FOUNDATION AND JILL FUGLISTER FROM THE COALITION OF HEALTH FUTURE, PRESENTATIONS AND RESPONSE TO BOARD QUESTIONS AND COMMENTS ON ISSUES INCLUDING: INCENTIVES TO ADVANCE AND PROMOTE HEALTH AND WELLNESS; EARLY CHILDHOOD INTERVENTION; HOUSING; URBAN TRANSPORTATION PLANNING; ACCESS TO PUBLIC TRANSPORTATION, EDUCATION AND RECREATIONAL OPPORTUNITIES; AND THE HEALTH EQUITIES INITIATIVE. DIRECTION TO INCLUDE ALL PARTS OF MULTNOMAH COUNTY IN PANEL DISCUSSION.

DEPARTMENT OF COUNTY HUMAN SERVICES DIRECTOR JOANNE FULLER INTRODUCED THE PANEL SPEAKERS FOR PREVENTION, POLICY AND PRACTICES.

PAULINE ANDERSON, FORMER MULTNOMAH COUNTY COMMISSIONER, AND LOLENZO POE, POLICY ADVISORY FOR CHAIR WHEELER, PRESENTATIONS ON

ISSUES INCLUDING: EARLY CHILDHOOD PREVENTION EFFORTS; POLICY ADVISORY ASSISTANCE OF THE COMMISSION ON CHILDREN AND FAMILIES; EFFORTS OF THE SUN SERVICE SYSTEM WHICH HAS BEEN WORKING WITH MANY PARTNERS FOR A PERIOD OF 15 YEARS AND HOW PROGRAM SERVICES REMOVE BARRIERS, HELP CHILDREN ACHIEVE SUCCESS AND PREVENT THEM FROM GETTING INTO TROUBLE.

CHAIR WHEELER ADDED THAT THE SUN SERVICE SYSTEM IS A COMMUNITY BASED PARTNERSHIP PROGRAM FUNDED BY PUBLIC AND PRIVATE DOLLARS; THAT THE SYSTEM IS RECOGNIZED NATIONALLY AND THAT LOLENZO TRAVELS ABOUT SHARING THE SUN SYSTEM MODEL TO INTERESTED PARTIES. COMMISSIONER ANDERSON ADVISED THAT THE SUN SYSTEM IS NOT ONLY A COMMUNITY EFFORT BUT ALSO CREATES COMMUNITY AND THAT SHE HAS SEEN THE SUN SYSTEM BRINGING COMMUNITIES TOGETHER. CHAIR WHEELER STATED THAT MANY OF THE SUN SCHOOLS ARE FUNDED BY GRANTS THAT LAST FOR THREE YEARS AND SOME ARE IN VERY IMPOVERISHED AREAS; AND THAT LAST YEAR WE HAD TO COMPROMISE AND SOME SCHOOLS GAVE UP THEIR RESOURCES, SO OTHER SCHOOLS IN THE POOREST AREAS HAVE SUN SCHOOLS.
