General Information

1. What action are you requesting from the Board?

The Assessor is requesting the Board approve the private sale of a tax foreclosed property to the adjacent owners Jeffrey A. Wilson & Brian N. Kasper.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The subject property R299248 was foreclosed on for delinquent property taxes and came into County ownership on October 11, 1996. The adjacent property owners at 3705 SE Tibbetts St. contacted the County about purchasing the contiguous strip at private sale per ORS 275.225. The Property conforms to the requirements in ORS 275.225 in that (1) it is not suitable for construction or placement of a dwelling (it is approximately 300 square feet), and (2) has a real market value of less than \$15,000 (estimated real market value is \$300). The adjacent owners offered to purchase the strip for \$300 from the County and plan to consolidate the parcel into their main account.

This action affects our Program Offer 72038 by placing a tax foreclosed property back onto the assessment roll.

3. Explain the fiscal impact (current year and ongoing).

The private sale will allow for recovery of the delinquent taxes, fees, and expenses, totaling

\$139.99. The sale will also reinstate the property onto the tax roll.

4. Explain any legal and/or policy issues involved.

The parcel will be deeded "As Is" without guarantee of clear title and is authorized under ORS 272.225.

No citizen or government participation is anticipated.
