This is Amendment No. 02 to the Agreement between the **State of Oregon**, acting by and through its Department of Transportation, hereinafter referred to as "State," and **MULTNOMAH COUNTY**, acting by and through its elected officials, hereinafter referred to as "Agency," entered into an Agreement on April 2, 2013 and Amendment Number 01 executed on January 28, 2016. Said Agreement covers production of design plans and construction of improvements for Arata Road including sidewalks, cross-walks, bike facilities, street lighting, landscaping, and green street drainage.

It has now been determined by State and County that the Agreement referenced above shall be amended to update Master Certification Agreement No. and Project Milestone dates for #2 Obligation Right-of-Way phase of the Project, #3 "Obligation for the Construction Phase" and #4 "Project Completion". Except as expressly amended below, all other terms and conditions of the Agreement are still in full force and effect.

1. **Effective Date.** This Amendment shall become effective on the date it is fully executed and approved as required by applicable law.
2. **Amendment to Agreement.**

RECITALS, Paragraph 3, Page 1 which reads:

3. The Project in this Supplemental Project Agreement is one of the required test projects that constitute conditional certification described in Local Agency Certification Program (Certification Program) Agreement No. 26226.

Shall be deleted in its entirety and replaced with the following:

3. The Project in this Supplemental Project Agreement is one of the required test projects that constitute conditional certification described in Local Agency Certification Program (Certification Program) Agreement No. 29110.

Exhibit B, Section 4, Project Milestones, Page 9, which reads:
