FELICIA TRADER, JOHN SOUTHGATE, JIM RALEIGH AND ABE FARKAS PRESENTATION AND RESPONSE TO BOARD QUESTIONS AND DISCUSSION, INCLUDING THE IMPACT CREATION OF THE DISTRICT WILL HAVE ON THE COUNTY'S LOCAL OPTION LEVY FOR THE LIBRARY, IN ADDITION TO LOSS OF REVENUE TO THE COUNTY GENERAL FUND.
