1. What action are you requesting from the Board?

Approval of Amendment 1 to an Intergovernmental Agreement #28483 with the Oregon Department of Transportation (ODOT). The Amendment updates project description, key milestone dates, total project cost and funding sources, and adds Exhibit D to include a description of environmental services to be performed.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

- The original project specified construction of bike lanes on both sides of the road; however during public outreach and communication with Multnomah County bike/pedestrian committee it was determined that constructing a shared path for bike traffic on the north side of the road, instead of bike lanes on both the north and south sides, will reduce the impact to adjacent properties and reduce the overall project cost. This amendment addresses these changes.
- The Federal Highway Administration and ODOT requested exchanging Congestion Mitigation and Air Quality funds with Surface Transportation Program funds to assist other agencies in delivering their projects. This has no impact to the total federal contribution to Arata Road project.
- Anticipated construction date is rescheduled to accommodate the right-of-way acquisition process of this project.
