Upon advice of the Tax Title Unit of Multnomah County that the contract purchaser, SHIRLEY N. LONG by contract dated February 24, 1988, agreed to purchase from Multnomah County upon terms and conditions provided therein, the following tax foreclosed property:

pursuant to authority of ORS 275.180, and that said purchaser is now in default of the terms of said contract in that purchaser failed to make monthly payments of \$86.98 since April 15, 1989 for a total of \$2,174.50, and that purchaser failed and neglected to pay before delinquency taxes for the years 1988/89 1989/90 1990/91 in the amount of \$4,163.60 plus interest which were lawfully assessed and levied against said property.

It appearing to the Board that ORS 275.220 provides that upon such default or breach of said contract, the Board may cancel said contract:

NOW, THEREFORE, it is hereby ORDERED that the subject contract be and is declared CANCELLED.

IT IS HEREBY FURTHER ORDERED that the Multnomah County Tax Collector remove the above property from taxation and cancel all unpaid taxes in accordance with the provisions of ORS 275.240.

IT IS HEREBY FURTHER ORDERED that the TAX TITLE UNIT OF THE DEPARTMENT OF ENVIRONMENTAL SERVICES mail a certified copy of this order by registered mail to SHIRLEY N. LONG at 4374 SE COTTONWOOD CT MILWAUKIE, OR 97222, and a return of such service be made upon such copy of the order.
