

**BEFORE THE BOARD OF COUNTY COMMISSIONERS
FOR MULTNOMAH COUNTY, OREGON**

RESOLUTION NO. 2015-060

Authorizing the Private Sale of a Tax Foreclosed Property as Allowed Under ORS 275.225 to E. Linda Wenning.

The Multnomah County Board of Commissioners Finds:

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A (the "Property").
- b. ORS 275.225 allows the County to sell County owned property, including property acquired through tax foreclosure, at a private sale if that property meets certain conditions with respect to value and the applicable zoning and building codes.
- c. The Property has a real market value of \$3,710 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1)(a).
- d. Although no written confirmation from the City of Portland was obtained, the County is confident that the location and size of the Property make it unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1)(b).
- e. The County has received payment in the amount of \$2,100 from E. Linda Wenning, an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the deed attached as Exhibit A, conveying the Property to E. Linda Wenning, in consideration of \$2,100.

MULTNOMAH COUNTY, a political subdivision of the State of Oregon, **Grantor**, conveys to E. Linda Wenning, **Grantee**, the following described real property:

Parking Unit P33, DIVISION PLAZA CONDOMINIUMS, in the City of Portland, Multnomah County, Oregon. TOGETHER WITH the limited common elements and the undivided interest in the general common elements appurtenant thereto, as set forth in Declaration of Condominium Ownership recorded August 16, 2006, Recorder's No. 2006 152502. ALSO TOGETHER WITH that shared access, parking, drainage and utility easement recorded November 22, 2004, Recorder's No. 2004 211980.
