General Information

1. What action are you requesting from the Board?

Approval of County Human Services (DCHS) application in response to the Oregon Youth Development Council's Request for Applications (RFA).

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Following State Legislature sunset of the Commission on Children and Families system, the Oregon Youth Development Council (YDC) was created under the Oregon Education Investment Board (OEIB). The YDC is tasked with creating a system of care, statewide, that eliminates barriers to youth school and work success – particularly youth of color.

Similarly to the Early Learning HUB process that resulted in the creation of *Early Learning Multnomah* (ELM), the County is expected to conduct a planning process in order to apply under the YDC RFA, due June 21, 2014.

The County currently receives an allocation of funds that are now identified to be awarded

through the RFA. In order to continue to receive some or all of current funding and seek to maintain current service levels, the County must compete and win award through the RFA.

In FY14 the County has been allocated a total of \$463,714 - \$302,582 SUN Service System Social and Support Services for Educational Success (SSSES) and \$161,132 Runaway Youth Shelter and Support Services.

3. Explain the fiscal impact (current year and ongoing).

There is no fiscal impact in FY14. In FY15, if the County is unsuccessful in its application the following reductions will be made in pass-through: PO 25149 SSSES, \$302,582 and PO 25138 Runaway Youth, \$161,132.

4. Explain any legal and/or policy issues involved.

There are no legal issues involved. The County has adopted policy in number of areas related to the services currently provided, including those regarding school achievement, anti-poverty, racial/ethnic disparities and culturally specific services.

5. Explain any citizen and/or other government participation that has or will take place.

Building on the existing collaboration with All Hands Raised, the Coalition for Communities of Color, and other partners, DCHS seeks to continue existing services within the YDC framework while exploring potential new services and services that are focused on increasing the number of Multnomah County youth who succeed in school and work.

There is no match currently identified. Reporting requirements are to be determined by the YDC in the future.

Initial funding commitment is through June 30, 2015. Given anticipated Legislative appropriation, funding is expected to continue through June 30, 2017, at a minimum.

On or about September 30, 2014 through June 30, 2015.
- **When the grant expires, what are funding plans?**
It is anticipated that grant funds will be renewed for the 2015-17 biennium, based on satisfactory performance and legislative appropriation.
