COMMISSIONER JUDY SHIPRACK

Lora Goode - 15 Years (start date: 10/2/2000)
Position: Animal Care Technician
Department of County Services
Division: Animal Services

Today I am going to talk a little bit about Lora Goode; Lora, please stand up.

Lora has dedicated her life to animals in our community. She previously worked with the Oregon Humane Society and Guide Dogs for the Blind, but for the past 15 years she has served the public as an Animal Care Technician at Animal Services. She works hard to provide care, assessment and new homes for shelter dogs and cats. Additionally, Lora often takes home some of the harder-to-adopt pets to give them a chance to blossom in a less stressful environment. A recent foster dog, Spot, is a small white semi-feral dog who was unwilling to let anyone touch him in the shelter. Lora brought him first into her office and then into her home, where every day he grows a little less fearful under her care.

In the past, when inclement weather threatened to make roads impassable overnight, Lora has been known to spend the night at the shelter to make sure that someone is there in the morning to feed and care for shelter animals, no matter what. Her caring doesn't stop with the animals though.

Lora's family and co-workers benefit from her generous spirit as well. Co-workers describe her as "nurturing, dependable and someone who handles stress beautifully. "

Some people find hard to believe that this young man has worked at Multnomah County Library for 20 years! When you discover that he was hired as a page right after high school, it makes a little more sense. Before that he was a library volunteer, and before **that** he was a library kid who went to the St. Johns library often with his mom. Steve was selected as Library Paraprofessional of the Year by Library Journal in 2008, where they noted Steve's "accomplishments during his tenure at Multnomah County Library touch upon almost everything the library does: developing employee training, introducing chat reference, supervising a branch while the manager is on leave, conducting story-times, mentoring new staffers, working on interlibrary loan and hiring, and even serving on a statewide board for online reference." He is involved with so many different aspects of the library and is currently a Lead Worker at the Central Library, where he has worked for the past 10 years.
