Dear Steve,

I am writing today to let you know that the development of the Resource Access Center is an extremely high priority for Multnomah County. The creation of the center will move our community a huge step forward in the battle toward ending homelessness.

Nearly five years ago, the Board of County Commissioners adopted the 10-year Plan to End Homelessness. Along with our partners at the city of Portland, the strategic plan calls for us to take direct steps that will help some of our most vulnerable people. The Resource Access Center will be a huge and effective part of that plan.

As you know, once an individual or family gets caught in the spiral of homelessness, there is literally no chance to pull out of it unless there is access to shelter, food and health care. But moving someone on a path toward transitional and then permanent housing doesn't happen overnight. The Resource Access Center will allow outreach workers from Transition Projects Inc. to connect with homeless people, find resources to move them off the streets and open opportunities for them to turn their lives around.

The beauty of the Resource Access Center is that it gives us a chance to develop partnerships in this important work, something that I have been pushing so that we can get the most out of every dollar we spend on important social service programs in this depressed economy. Multnomah County's Health Department is considering moving its Tuberculosis Clinic to the new center. Also, we are exploring the possibility of moving other resources, such as the Community Court and veterans outreach workers from our Aging and Disability Services division, to the site.

I am excited about the possibilities that will rise up from the development of the Resource Access Center. Consider this a solid endorsement from Multnomah County for this project. We look forward to working with the Housing Authority of Portland and Transition Projects Inc. on this important project.

Responding to the State Revenue Forecast May 15, 2009

Today's state revenue forecast brings more difficult news. Final budget decisions from the Oregon legislature will take time, but we estimate that Multnomah County will lose \$25 million to \$50 million in state-funded services based on today's forecast.

The Governor's proposed budget in January reduced services for seniors, mental health and substance abuse treatment, dental care and supervision of offenders in the community by up to 90%, assuming a much smaller shortfall. The legislature's budget choices will differ, but reductions are likely in any event.

Multnomah County will probably face two rounds of service reductions. Between now and June 4 we will reduce services to match county budget resources. Soon after that, the final state budget will likely necessitate a second round of cuts.

There are no easy answers. Oregon legislators face extremely difficult decisions and they will need our support. Holding any particular service harmless from budget cuts forces even deeper cuts in other areas. Elected leaders need to work together to maintain the most critical services, regardless of which jurisdiction provides them.

The public's attention to government budget decisions at every level is crucial to help hold us accountable and help us find a way through this crisis.

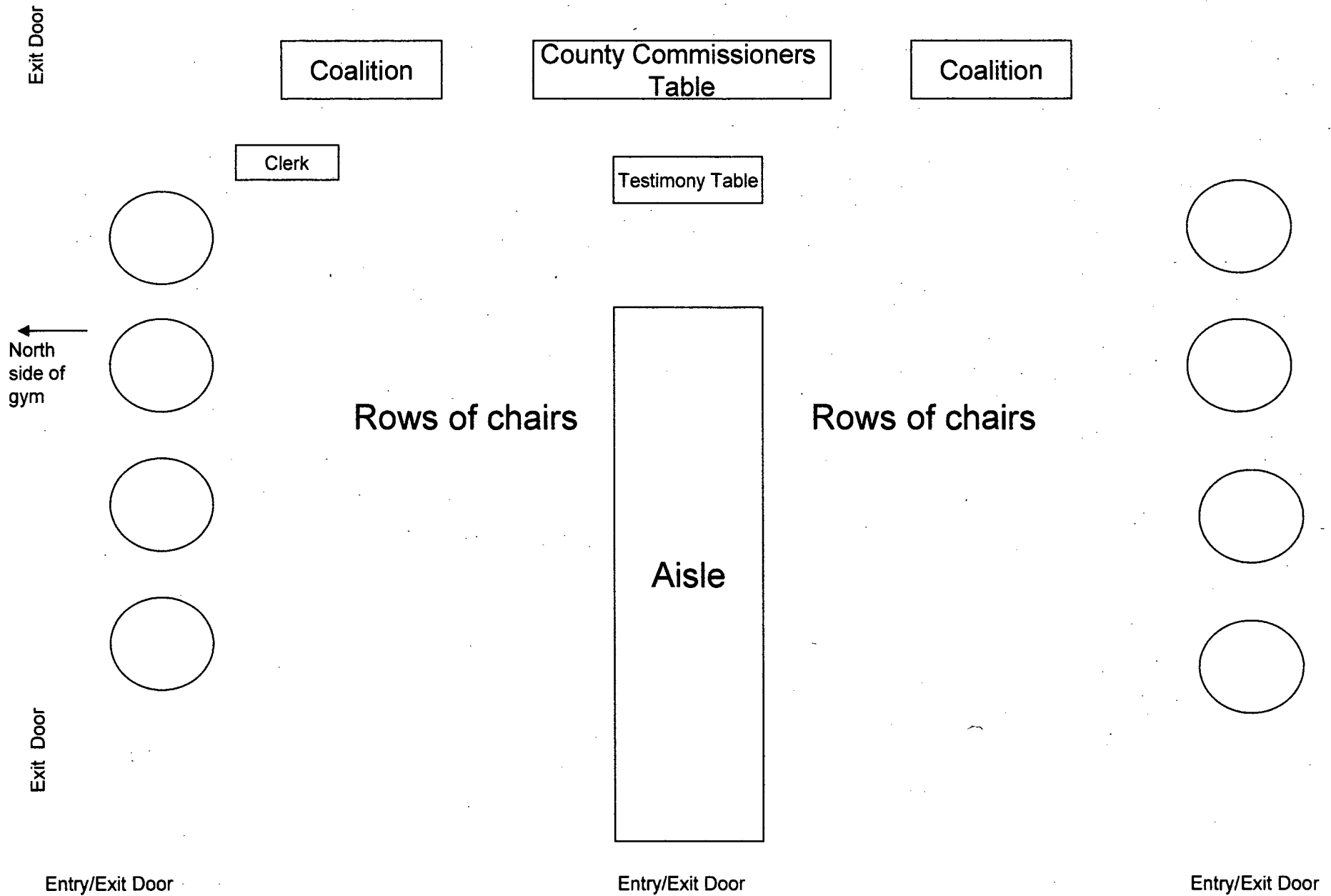



Project Pilot Goals



- Reduce in-school suspensions, suspensions and expulsions, particularly among students of color.
- Reduce the number of school-based referrals to Juvenile Services Division, particularly among students of color.
- Create a replicable program that aligns the juvenile justice and secondary educational systems in manner that promotes long-term reductions in juvenile delinquency and student expulsion and suspension.

Results

Between Oct. '08 - March '09

- 93 students/cases facilitated.
- On average, 95% of cases ended in an agreement.

Between Oct. '08 – December '08

- 91% of the cases successfully closed with no further incidents 90-days after the initial agreement.
- The remaining 9% of the cases opted to extend their agreements.

Results

Student Surveys:

- 79% felt the RI was helpful.
- 85% felt the agreement was realistic and understandable.
- 88% felt confident in their ability to complete the agreement.
- 85% felt satisfied with the RI process.
- 85% percent felt the harm had been repaired.



Thank you for giving me the opportunity to address you today. As you can probably see I'm advocating for the Sheriff's budget – to ask you to reinstate some of the cuts that have been put on the table.

I have heard a lot of testimony at the last two budget hearings. All of these programs are important and have changed many lives.

There is just one issue that I feel needs to be put to the forefront and made top priority. None of these programs work if these citizens aren't safe and protected. From my experience with government, I keep finding over and over that public safety is the number one purpose of government. Many of these people rely on city police staff, but the sheriff's department is also an integral part of public safety for all citizens.

Not until recently when I went to meetings that outlined all of the things that the Sheriff's Dept. does, I was amazed. They are many social service programs in themselves.

Living in a rural, unincorporated area like Corbett for many years, you see how much crime can be generated there. Huge marijuana busts, cars being stripped along our country roads, bodies from Portland being dumped in our area, drug and theft rings.

A major deterrent to crime is to catch it at its source. If we can retain the Special Investigations Unit, we can catch a lot of criminal activity before it hits the cities. Take the drugs off the streets before they affect people, young and old, resulting in addiction.

East Metro Gang Enforcement. Huge problem in the greater Gresham area and affecting many young people from other countries as they struggle to identify themselves in a different culture in the wrong ways.

Weekender Program at the Courthouse Jail. It just makes sense to allow lower level offenders to serve their time on weekends – let them still be able to work at their jobs and support themselves and their families.

We need to find permanent funding for the Sheriff's Dept., but right now we need to keep as many programs in place as possible or continued crime is going to escalate out of control, especially in this economy. With all of the publicity about lack of funding, we might as well have huge billboards on the freeways saying: hey criminals, come on out to the rural areas – we have no law enforcement here.
