General Information

1. What action are you requesting from the Board?

Request approval of Budget Modification NOND-08 transferring \$50,000 from general fund contingency to the Department of County Human Services (DCHS) to fund activities of Black Women for Peace.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Black Women for Peace (BWFP) is working to reduce youth and family violence and increase social justice and peace across diverse communities. Multnomah County will invest \$50,000 to cultivate this work, with the goals of enabling BWFP to operate independently of the County and encouraging collaboration with the County on initiatives and programs designed to reduce youth and gang violence. During the annual budget process, the Board approved an amendment to earmark \$50,000 in contingency for BWFP. This budget modification will move the funds from the General Fund Contingency into program offer 25123 Youth Gang Prevention in DCHS.

3. Explain the fiscal impact (current year and ongoing).

This funding affects FY 2012 only.

4. Explain any legal and/or policy issues involved.

5. Explain any citizen and/or other government participation that has or will take place.

Black Women for Peace involves many members of the community. They have been active at meetings with government and the community, such as "Stop the Violence" sessions sponsored by the Department of Community Justice, strategy discussions called for by the Mayor, and Commissioner Smith's 2011 town hall event focused on African American men and youth. They are planning activities to engage youth, families, and the community.

SUBJECT: General Fund Contingency request of \$50,000 for the Department of County Human Services to fund Black Women for Peace (Budget Modification Nond-08)

Commissioner Smith is requesting \$50,000 of General Fund contingency be appropriated to Black Women for Peace (BWFP). BWFP is a group that was convened by District 2 to engage the community in addressing youth and gang violence. Black Women for Peace has begun to identify and address the root causes of youth and gang violence in our community, and has worked closely with the Portland State University School of Social Work on research projects and on developing potential solutions. \$50,000 was earmarked in the FY 2012 Adopted General Fund contingency to enable this group to operate independently of the County. This action appropriates the funds from General Fund contingency to program offer 25123 Youth Gang Prevention in the Department of County Human Services.

General Fund Contingency Policy Compliance

The Budget Office is required to inform the Board if contingency requests submitted for approval satisfy the general guidelines and policies for using the General Fund Contingency.

Because this request was earmarked by the Board in contingency during the FY 2012 budget process, funding this request meets the criteria for acceptable use of contingency under our Financial Policies.
