STEPHANIE SODEN PRESENTATION AND RESPONSE TO BOARD QUESTIONS AND DISCUSSION ON ISSUES INCLUDING BUDGET REBALANCE PACKAGE; LIST OF CUTS THAT HAVE DIRECT IMPACT ON COUNTY PROGRAMS AND SERVICES; ESTIMATED AMOUNT OF CUTS AND IMPACT ON COUNTY PROGRAMS AND SERVICES; IMPACT OF TEMPORARY INCOME TAX INCREASE IF APPROVED BY VOTERS; CUTS RESCINDED BY GOVERNOR AFTER LEGISLATURE ADJOURNED. MS. SODEN REPORTED THAT THE HOUSE TASK FORCE AND GOVERNOR'S TASK FORCE ARE WORKING ON PUBLIC EMPLOYEE RETIREMENT SYSTEM (PERS) ISSUES AND THAT THE OREGON OFFICE OF ECONOMIC ANALYSIS IS

EXPECTED TO RELEASE ITS NEXT ECONOMIC AND REVENUE FORECAST IN NOVEMBER. PUBLIC AFFAIRS OFFICE TO CONTINUE TO MONITOR LEGISLATIVE AND BUDGETARY ACTIVITIES AND UPDATE THE BOARD.

JUDY BARNES ON BEHALF OF OREGON PUBLIC POWER COALITION, TESTIMONY IN SUPPORT OF BOARD RESOLUTION 02-122 AND URGING THE BOARD TO ENSURE THAT THE NEW ENTITY IS ACQUIRED AT A FAIR PRICE; THAT IT INCLUDES RETENTION OF EXISTING COLLECTIVE BARGAINING AGREEMENTS AND BENEFITS TO ALL PGE EMPLOYEES; AND THAT GOVERNANCE IS VESTED IN A RATEPAYERS ELECTED BOARD OF DIRECTORS. COVINGTON TESTIFIED IN SUPPORT OF AN OPEN AND HONEST PROCESS. COMMISSIONER ROBERTS COMMENTED HE FEELS STRONGLY THAT THE WORKERS NEED TO BE PROTECTED.
