General Information

1. What action are you requesting from the Board?

Approval of Intergovernmental Agreement (IGA) with the Oregon Department of Transportation (ODOT) for the Burnside Bridge Maintenance Project (hereafter, referred to as "the project").

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The County signed IGA #29375 with ODOT authorizing the design phase of this project on October 15th, 2013. Due to changes in the State Bridge Program, ODOT has drafted a new IGA with the County that incorporates those changes and that covers all phases of the project instead of amending the original IGA. The new IGA will supersede the original IGA when it is signed. The new IGA sets the project budget at \$29,983,000 for design and construction. \$26,903,746 (89.73%) will be Federal funds and \$3,079,254 (10.27%) in local match will be County funds.

The purpose of the Burnside Bridge Maintenance Project is to extend the service life of this bridge 15-20 more years, while the Transportation Division explores the feasibility of seismic upgrades in the future. Design is currently underway and construction is anticipated to begin in Spring 2017.

3. Explain the fiscal impact (current year and ongoing).

The project is funded using 89.73% federal funds and 10.27% County funds. The County match is included in the Bridge Section budget for FY 2016 and FY 2017.

4. Explain any legal and/or policy issues involved.

There are no legal or policy impacts.

5. Explain any citizen and/or other government participation that has or will take place.

The project has developed a detailed public outreach plan and will be guided by targeted stakeholder outreach designed to:

- Engage key stakeholders (public agencies, impacted properties, user groups, and other key community groups) to provide project awareness and capture feedback about their concerns, desires, and suggestions as they relate to bridge rehabilitation and anticipated construction impacts.
- Provide a collaborative, transparent process for the sharing of information, exchange of ideas and informed consultation with the agencies and key stakeholders.
- Inform the general public on the project purpose and need, schedule, and opportunities to comment.
